BY THE COMMISSION:

SIXTH SUPPLEMENTAL ORDER

The Pasadena City Lines, Inc., in its Fourth Supplemental Application No. 23776 asks for authority to amend the description of a portion of two of its motor coach routes, as described in Section III of the Order in Decision No. 33750 and as amended by Section II of the Order in Decision No. 34973.

It appears that this is not a matter in which a public hearing is necessary and that the request should be granted, therefore;

IT IS HEREBY ORDERED that the description of the Los Robles Avenue Route and the California Street-Allen Avenue Route, as described in Section III of the Order in Decision No. 33750 and as amended by Section II of the Order in Decision No. 34973 be and they are hereby further amended to read as follows:

LOS ROBLES AVENUE ROUTE:

From the corner of Colorado Street and Raymond Avenue; thence southerly on Raymond Avenue to Green Street; thence westerly on Green Street to Fair Oaks Avenue; thence northerly on Fair Oaks Avenue to Colorado Street; thence easterly on Colorado Street to Los Robles Avenue; thence northerly on Los Robles Avenue to Woodbury Road; thence northwesterly on Woodbury Road to Santa Anita Avenue; thence northerly along Santa Anita Avenue to Calaveras Street, and return over the same route.

CALIFORNIA STREET - ALLEN AVENUE ROUTE (Section No. 1)

From the corner of Colorado Street and Raymond Avenue southerly on Raymond Avenue to Green Street; thence westerly on Green Street to Fair Oaks Avenue; thence northerly on Fair Oaks Avenue to Colorado Street; thence easterly on Colorado Street to Los Robles Avenue; thence southerly on Los Robles Avenue to California Street; thence easterly on California Street to Lake Avenue; thence northerly on Lake Avenue to San Pasqual Street; thence easterly on San Pasqual Street to Hill Avenue; thence northerly on Hill Avenue to Oakdale Street; thence easterly on Oakdale Street to Allen Avenue; thence northerly on Allen Avenue to New York Avenue; and return over same route.

CALIFORNIA STREET - ALLEN AVENUE ROUTE (Section No. 2)

From the corner of Green Street and Fair Oaks Avenue southerly on Fair Oaks Avenue to California Street; thence westerly on California Street to Arroyo Boulevard; thence southerly on Arroyo Boulevard to La Loma Road; thence easterly on La Loma Road to Grand Avenue; thence northerly on Grand Avenue to California Street; thence easterly on California Street to Fair Oaks Avenue; thence northerly on Fair Oaks Avenue to Green Street; thence easterly on Green Street to Raymond Avenue; thence northerly on Raymond Avenue to Colorado Street; thence westerly on Colorado Street to Fair Oaks Avenue; thence southerly on Fair Oaks Avenue to point of beginning.

In all other respects Decisions Nos. 33750 and 34973 shall remain in full force and effect.

The effective date of this Order shall be the date hereof.
