BY THE COMMISSION:

ORDER

In Decision No. 36106 in this application the Commission, by Interim Order, authorized Key System to operate its Richmond Ship-yard Railway across the various streets and highways lying between the terminus at Yerba Buena Avenue and Hollis Street, Oakland, and 9th Street, Richmond, these being the limits of the operation commenced on January 18, 1943. Applicant now proposes to extend operations to serve additional shipyards in Richmond and has requested authority for the remaining crossings.

Good Cause Appearing;

IT IS HEREBY ORDERED that Key System is hereby authorized to operate a double track electrically operated main line railroad at grade across the streets shown on Appendix "AA" attached hereto, subject to the following conditions:

- (1) Said crossings shall be identified as shown on said Appendix "AA" and shall be protected in the manner shown thereon. Construction of said highway crossings shall be equal or superior to the Commission's Standard No. 2 of G. O. No. 72, and of a width to conform to the portion of the streets now graded, with tops of rails flush with readways and with grades of approach conforming as nearly as practicable to the existing grades of said streets.
- (2) Pending the installation of the wigwags or flashing lights, as required and shown on Appendix "AA," the crossings shall be protected by human flagmen on duty at all times trains are operated over said crossings.
- (3) Within thirty (30) days after completion pursuant to this and our prior order in Decision No. 36106, applicant shall so advise the Commission in writing.

(4) This authorization shall become void if not exercised within one year from the date hereof, unless time be extended, or if above conditions are not complied with.

Authorization granted herein and in Decision No. 36106 may be rovoked or modified if public convenience, necessity, or safety so require.

This order shall be effective immediately.
