OPINION

ORIGINAL

In its first supplemental application Peerless Stages,
Incorporated requests the Commission to authorize it to use an
additional route within the city of Palo Alto. It is asserted
that the use of this additional route would enable applicant to
better serve a large group of employees of the Westvaco Chlorine
Products Corporation of Newark, California who live within the
residential area of Palo Alto traversed by said route.

The proposed additional routing of applicant will not adversely affect local transportation within the city of Palo Alto because of a restriction existing in applicant's certificate prohibiting local service in this area. It is our judgement that the

The Mayor of the city of Palo Alto has also written to the Commission that the proposed additional routing of applicant would be of benefit to the residents of the area effected.

authority requested is in the public interest and should be granted. This will be accomplished by amending the present route of applicant as described in the service regulations of the order of the Commission's decision No. 35763. No public hearing is necessary.

## ORDER

IT IS HEREBY ORDERED that <u>Route No. 2 - Palo Alto</u>:, as defined in service regulation No. 2 of the order of Decision No. 35763, dated September 15, 1942, in the following language:

"Beginning at the intersection of Main Street and Thornton Avenue (Centerville), thence along Thornton Avenue (also known as Legislative Route #107) (Newark), Dumbarton Highway, Willow Road, Middlefield Road, Lytton Street, to Alma Street in the City of Palo Alto."

is hereby amended to read as follows:

## "Route No. 2 - Palo Alto:

- "(a) Beginning at the intersection of Main and Thornton Avenue (Centerville), thence along Thornton Avenue (also known as Legislative Route #107)(Newark), Dumbarton Highway, Willow Road, Lytton Street to Alma Street in the City of Palo Alto.
- "(b) Commencing at the intersection of Willow Road and Bayshore Highway, thence along Bayshore Highway, thence along University Avenue to Alma Street in the city of Palo Alto."

IT IS FURTHER ORDERED that Decision No. 35763 shall in all other respects remain in full force and effective.

The effective date of this order shall be the date hereof.
