BY THE COMMISSION:

O R D E R

San Diego Electric Railway Company, a corporation, requests a certificate of public convenience and necessity to establish a passenger stage service between the present outer terminal of its Route "O" bus line at Del Mar Avenue and the Azure Vista Housing Project located on Point Loma. This project, constructed by the Federal Housing Administration, contains 400 units, intended to be occupied by people employed in essential war industries. The project at this time contains no shopping or recreational facilities, schools or churches, and no public transportation is at present afforded that area whereby these facilities may be reached.

No public hearing appears to be necessary and, after full consideration of the instant application, it is our judgment that the authority sought is in the public interest and should be granted; therefore,

IT IS ORDERED that a certificate of public convenience and necessity is hereby granted to San Diego Electric Railway Company, authorizing the establishment and operation of service, as a passenger stage corporation as defined in Section 2½ of the Public Utilities Act, for the transportation of passengers along the route

proposed in the instant application, provided that:

San Diego Electric Railway Company, its successors or assigns, may never claim before this Commission or any court or other public body, a value, for any purpose, for the certificate herein granted in excess of the actual cost incurred by it in securing said operative authority.

IT IS FURTHER ORDERED that in the operation of passenger stage service, pursuant to the foregoing certificate, the following service regulations shall be complied with:

- (1) Applicant shall file a written acceptance of the certificate herein granted within a period of not to exceed thirty (30) days from the effective date hereof.
- (2) Applicant shall comply with the provisions of General Order No. 79 and Part IV of General Order No. 93-A, by filing, in triplicate, and concurrently making effective, tariffs and time schedules satisfactory to the Commission, within sixty (60) days from the effective date hereof and on not less than one (1) day's notice to the Commission and the public.
- (3) Subject to the authority of this Commission to change or modify it at any time by further order, applicant shall conduct this passenger stage service over and along the following route:

Commencing at the intersection of Sunset Cliffs Boulevard and Del Mar Street; thence via Sunset Cliffs Boulevard and Cordova Drive to Brindisi Street.

- (4) Applicant may turn its motor vehicles at termini or intermediate points either in the intersection of the street or by operating around a block, contiguous to such intersection, in either direction.

The effective date of this Order shall be the date hereof.
