## FIRST SUPFLEMENTAL OPINION

Mary Maritzen and E. B. Osthues, applicants herein, were granted a certificate of public convenience and necessity on (1)
September 9, 1942, to operate as a passenger stage corporation between Modesto and Hammond General Hospital, situated approximately three miles northwest of Modesto.

Applicants have now filed a supplemental application the purpose of which is to effect a slight change in route within the city of Modesto, by which their buses will operate from 11th and I Streets, east on I Street to 12th Street, south on 12th Street to H Street, west on H Street to 9th Street and north on 9th Street to I Street, said route to be in addition to the present operation. The effect of such change would be to permit applicants to use both I and H Streets in coming to and leaving the Modesto terminus, thus avoiding unnecessary or hazardous turns, and at the same time conform with municipal traffic rules.

No other changes are proposed, nor is there involved any variation in time schedules or fares. We believe the proposed change in route is in the public interest and the application will therefore be granted. A public hearing does not appear necessary.

## FIRST SUPPLEMENTAL ORDER

IT IS ORDERED that service regulation No. 3 of Décision No. 35800, dated September 29, 1942, reading as follows:

"3. Subject to the authority of the Commission to change or modify it at any time by further order, applicants shall conduct said passenger stage service over and along the following route:

Commencing at the Courthouse Square at 11th and "I" Streets in the City of Modesto; thence via "I" Street to 9th Street, also known as U.S. Highway No. 99; thence north along 9th Street (U.S.Highway No. 99) to Blue Gum Avenue; thence west on Blue Gum Avenue to Hammond General Hospital.

Returning over the same route."

be and it hereby is deleted therefrom and that there is substituted in lieu thereof the following:

Commencing at the southwest corner of the intersection of Twelfth and Eye Streets; turning right on Twelfth Street; thence to H Street; to the right on H Street; thence to Ninth Street; to the right on Ninth Street; thence along Ninth Street, also known as U.S. Highway No. 99, to Blue Gum Avenue; thence west on Blue Gum Avenue to Hammond General Hospital.

Returning on Blue Gum Avenue over U. S. Highway No. 99 and Ninth Street to Eye Street; turning left on Eye Street; thence to the point of departure.

In all other respects said Decision No. 35800 shall remain unchanged and in full force and effect.

The effective date of this order shall be the date hereof.
