BY THE COMMISSION:

SUPPLEMENTAL ORDER

In the above entitled applications Fresno City Lines, Inc. was authorized to operate passenger stage service between Fresno and the U. S. Army Air Base (Hammer Field) and between Fresno and Camp Pinedale, respectively.

Both of these lines terminate in Fresno in a loop around the block bounded by Mariposa Street, Broadway, Fulton Street, and Fresno Street. In order to properly accommodate the increasing traffic to the two Army camps during peak travel hours, additional street space at the Fresno terminus is required, and applicant now requests authority to extend this loop to include the three blocks bounded by Mariposa Street, Broadway, Inyo Street and Fulton Street.

It appears that this is not a matter in which a public hearing is necessary and that the request should be granted, therefore,

IT IS HEREBY ORDERED that the description of applicant's passenger stage service between Fresno and the U. S. Army Air Base, (Hammer Field) as described in Condition 2, Section II of Decision

No. 34404 in Application No. 24224 be and it is hereby further amended to include a loop in either direction around the blocks bounded by Mariposa Street, Broadway, Inyo Street and Fulton Street.

IT IS HEREBY FURTHER ORDERED that the description of applicant's passenger stage service between Fresno and Camp Pinedale as described in Condition 2, Section IV of Decision 35820 in Application No. 24937 is hereby amended to include a loop in either direction around the blocks bounded by Mariposa Street, Broadway, Inyo Street and Fulton Street.

In all other respects said Decisions Nos. 34404 and 35820 shall remain in full force and effect.

The effective date of this order shall be the date hereof.
