ORDER OF MODIFICATION

A written request therefor having been received from counsel for applicant in the above entitled proceeding and good cause appearing,

IT IS ORDERED that the following language appearing at sheet 3 of Decision No. 36652 (Application No. 25435), to wit:

"between Santa Rosa and Monte Rio and intermediate points, and between Sebastopol and Cotati and intermediate points via Smith's Corner, Sebastopol, Graton, Sousa's Corner, Forestville, Hilton, Santa Nella, Rio Nido, Guerneville, Occidental and Camp Meeker subject to the following conditions; exception and limitation:"

is deleted therefrom and the following language is substituted in the place and stead thereof:

"between Santa Rosa and Monte Rio and intermediate points via Sebastopol, Graton, Forestville, Hacienda and Rio Nido; between Sebastopol and Cotati and intermediate points; between Monte Rio and Graton and intermediate points via Occidental; between Santa Rosa and North Graton Jct. and intermediate points via Sousa's Corner; between Sousa's Corner and South Graton Jct., and intermediate points; between Guerneville and Forestville and intermediate points via Santa Nella; between Santa Nella and Korbel Ranch and intermediate points; between Occidental and Smith's Corner and intermediate points via Molino, subject to the following conditions and limitations:"

IT IS FURTHER ORDERED that the last ordering paragraph of the order of said Decision No. 36652, appearing at sheet 5 thereof, is hereby amended to read:

"IT IS FURTHER ORDERED that the operative rights created by or acquired pursuant to Decision No. 28367, rendered November 18, 1935; Decision No. 24925, rendered June 27, 1932; Decision No. 25993, rendered May 29, 1933, and Decision No. 28943, rendered June 29, 1936, are and each of them is hereby revoked and annulled."

IT IS FURTHER ORDERED that said Decision No. 36652 shall in all other respects remain in full force and effect.

The effective date of this order shall be the date hereof.
