



## BEFORE THE RAILROAD COMMISSION OF THE STATE OF CALIFORNIA

In the Matter of the Application of MININ A. PIALY, ONA DUSINESS as "Furniture Fast Freight" to limit cortificates of public convenience and necessity heretofore granted him by Decisions Nos. 33814, 35453, 34360, 34440 and 36204, so that such highway common carrier operations may be hereafter maintained only as an underlying carrier for the express corporation service of Melvin A. Pixley doing business as "Furniture Freight Forwarders."

## OPINION AND ORDER

In this application, Melvin A. Pixley, an individual doing business as Furniture Fast Freight, proposes to limit his operations as a highway common carrier to the transportation of property as an underlying carrier for his express corporation service conducted under the name of Furniture Freight Forwarders.

The limitation is proposed pursuant to a requirement of Decision No. 36824 of January 18, 1944, in Application No. 25830, in which Pixley was granted authority to operate as an express corporation. In that decision it was pointed out that if highway common carrier and express corporation operations were to be maintained concurrently the resulting duplication of service would be needlessly confusing to the shipping public; that this undesirable condition should be avoided by limiting the former operations to underlying carrier service for the latter operations; and that an application so to limit highway carrier service could be granted, if in satisfactory form, without the necessity of further hearing. The application will

Therefore, good cause appearing,

IT IS HEREBY ORDERED that the certificates of public convenience and necessity held by Melvin A. Pixley, doing business as Furniture Fast Freight, to operate as a highway common carrier by virtue of Decision No. 33814 in Application No. 23745, Decision No. 35453 in Application No. 24483, and Decision No. 36204 in Application No. 25155 be and they are hereby amended by limiting operations thereunder to transportation performed as an underlying carrier for Melvin A. Pixley, an express corporation doing business as Furniture Freight Forwarders.

IT IS MEREBY FURTHER ORDERED that, in the operation of the aforesaid highway common carrier service, Melvin A. Pixley shall comply with the provisions of General Order No. 80 and Part IV of General Order No. 93-A by filing, in triplicate, and concurrently making effective, tariffs and time schedules satisfactory to the Commission within sixty (60) days from the date hereof and on not less than three (3) days' notice to the Commission and the public.
