BY THE COMMISSION:

SECOND SUPPLEMENTAL OPINION

Applicants Mary Maritzen and E. B. Osthues are partners engaged in the operation of service as a passenger stage corporation, as defined by Section 2 $\frac{1}{4}$ of the Public Utilities Act, between the city of Modesto and Hammond General Hospital, a United States Army Hospital located approximately three miles northwest of Modesto.⁽¹⁾

Applicants have now filed a supplemental application the purpose of which is to establish an additional route within the city of Modesto by which their buses, in addition to the present route as fixed in Decision No. 35800, will also operate over L Street to 12th Street, 12th Street to Needham Street, thence over Virginia Street to Coldwell Avenue, over Coldwell Avenue to U. S. Highway 99, thence northerly on U. S. Highway 99 to Blue Gum Avenue and the Hospital and intermediate points, returning over the same route.

It is alleged in the application that the additional service will afford more adequate transportation to the military and

civilian personnel of the Hospital who reside in the city of Modesto and that request for such additional service has been made by the Commanding Officer of said Hospital.

No other changes are contemplated in the application, nor is there involved any change in time schedules or fares. No other carrier is effected by the proposed extension.

It appears to us that the proposed change in route is in the public interest and the application will therefore be granted. A public hearing is not necessary.

SECOND SUPPLEMENTAL ORDER

IT IS ORDERED that service regulation No. 3. of Decision No. 35800, dated September 29, 1942, be supplemented by adding thereto the following:

From the intersection of U. S. Highway No. 99 and L Street, east on L Street to 12th Street, thence north on 12th Street to end of 12th Street at Needham Street and Virginia Avenue; thence north on Virginia Avenue to Coldwell Avenue; thence west on Coldwell Avenue to U.S. Highway No. 99, returning over the same route.

In all other respects said Decision No. 35800 shall remain in full force and effect.

The effective date of this order shall be the date hereof.
