BEFORE THE RAILROAD COMMISSION OF THE STATE OF CALIFORNIA

In the matter of the application of PACIFIC GAS AND ELECTRIC COMPANY for an order authorizing applicant to enter into a written agreement with THE UNITED STATES GOVERNMENT relating, among other things, to the sale and conveyance by the former to the latter of the electric distribution facilities referred to in this petition.

OPINION AND ORDER

Pacific Gas and Electric Company asks permission to enter into an agreement with The United States of America, hereinafter sometimes referred to as the Government, in words and figures contained in the form therefor which is filed in this application as Exhibit "A" and to consummate said proposed agreement fully in accordance with its terms and conditions.

Under the terms of the agreement applicant will sell, transfer, and assign to the Government, for \$16,037.00, all of its right, title and interest in and to the poles, wires, transformers and associated facilities located in the Presidio of Monterey, and shown on drawing 20,120, sheet 1, attached to Exhibit "A." The agreement further provides that applicant will, at Government expense, fixed at \$8,397, reconstruct said electric

distribution system and the Government's street lighting system in the Presidio of Monterey as shown in sheets 2 and 3 of said drawing 20,120. Further, the Government will pay applicant \$388 to reconstruct applicant's distribution system outside the Presidio of Monterey so that it can continue service to customers outside the Presidio of Monterey.

Applicant's petition shows that the Government has asked applicant to deliver at one point and through one meter all electricity to be purchased by the Government from applicant for use within the Presidio of Monterey, and that in order for the Government to distribute said electricity within said reservation, it desires to acquire the electric distribution system mentioned herein.

The agreement contains the provisions under which applicant will supply electric service to the Government for use in the Presidio of Monterey. The rates charged the Government by applicant for such service will be those set forth in its Schedule C-6, or in such other applicable schedule in lieu thereof as may be authorized by the Railroad Commission of California.

The Commission has considered applicant's request and is of the opinion that this is not a matter on which a hearing is necessary, and that this application should be granted, therefore,

IT IS HEREBY ORDERED that the Pacific Gas and Electric Company be, and it is hereby, authorized to enter into an agreement with The United States of America in words and figures contained in the form of agreement filed in this application as Exhibit "A."

IT IS HEREBY FURTHER ORDERED that Pacific Gas and Flectric Company be, and it is hereby, authorized to consummate said agreement fully in accordance with its terms and conditions.

IT IS HEREBY FURTHER ORDERED that the authority herein granted will become effective upon the date hereof.
