ORIGINALOPINION AND ORDER

By this application Central Warehouse & Drayage Co., a corporation operating as a public utility warehouseman at San Francisco, seeks authority to transfer its prescriptive warehouse operative rights, property, leasehold interest and other assets and liabilities to Ben Cassinerio, doing business as Central Warehouse & Drayage Co. The transfer involves the turning in of the stock of the corporation and the assignment of all of the corporation's assets and liabilities to Cassinerio. Four of the five outstanding shares of stock are owned by Ben Cassinerio; the fifth is owned by Pearl Cassinerio, his wife.

The verified application shows that no change is to be made in the management or control of the utility warehouse business, or in the rates and service to the public.

It appears that this is a matter in which a public hearing is not necessary and that to the extent the application involves the transfer of operative rights and other property necessary and useful in the public utility warehouse operation in question, it should be granted.

Therefore, good cause appearing,

IT IS HEREBY ORDERED that Central Warehouse & Drayage Co., a corporation, be and it is hereby authorized to transfer, and Ben Cassinerio, an individual, doing business as Central Warehouse & Drayage Co., be and he is hereby authorized to acquire whatever prescriptive warehouse operative rights the corporation may now possess and other property necessary and useful in the public utility warehouse business involved in the above entitled application.

IT IS HEREBY FURTHER ORDERED that immediately upon the transfer of the property involved Central Warehouse & Drayage Co., a corporation, and Ben Cassinerio, doing business as Central Warehouse & Drayage Co., shall on not less than five (5) days' notice to the Commission and to the public, supplement or reissue the tariffs on file with the Commission in so far as they name rates, rules and regulations governing warehouse operations of Central Warehouse & Drayage Co., a corporation, at San Francisco, to show that it has withdrawn or canceled and that Ben Cassinerio, doing business as Central Warehouse & Drayage Co., has concurrently adopted or established as his own, said rates, rules and regulations; and that the tariff filings made pursuant to this order shall in all other respects comply with the regulations governing the construction and filing of warehouse tariffs set forth in the Commission's General Order No. 61.

This order shall become effective on the date hereof.
