## BEFORE THE RAILROAD COMMISSION OF THE STATE OF CALIFORNIA

In the Matter of the Application of  
 ASSOCIATED TELEPHONE COMPANY, LTD.,  
 a corporation, for authority to withdraw  
 its rates for eight-party residence  
 service in its Pomona exchange.

BY THE COMMISSION:

SECOND SUPPLEMENTAL ORDER

On July 15, 1941, the Railroad Commission authorized Associated Telephone Company, Ltd. to discontinue its eight-party residence telephone service in its Pomona exchange on or before December 1, 1942, in connection with the contemplated dial conversion of the central office equipment, provided a certain showing would have been made. (Decision No. 34414)

By Decision No. 35936, dated November 5, 1942, an extension of time was granted in which to make the desired changes from December 1, 1942 to December 1, 1944.

Associated Telephone Company, Ltd. now seeks a further extension to December 1, 1946, since it now appears that the proposed changes can not be made within the period allowed by the Railroad Commission's Order in Decision No. 35936, due to various governmental orders and restrictions relating to the use of telephone equipment and material.

The Commission has considered this matter and is of the opinion that the extension of time in which the proposed changes may be effected, as requested by the Applicant, is justified and should be granted, and that this is not a matter in which a public hearing is necessary, wherefore

IT IS ORDERED that the paragraph of the Order in Decision No. 35936, dated November 5, 1942, reading:

"IT IS HEREBY ORDERED that Associated Telephone Company, Ltd., after proper showing to the Railroad Commission that it has completed the installation of dial equipment in its Pomona exchange and is ready to replace all eight-party residence telephone service therein with four-party service at the rates proposed therein, and upon Supplemental Order of the Railroad Commission, may discontinue its eight-party residence service, provided such showing is made on or before December 1, 1944."

be, and the same is hereby amended to read:

IT IS ORDERED that Associated Telephone Company, Ltd., after proper showing to the Railroad Commission that it has completed the installation of dial equipment in its Pomona exchange and is ready to replace all eight-party residence telephone service therein with four-party service at the rates proposed therein, and upon Supplemental Order of the Railroad Commission, may discontinue its eight-party residence service, provided such showing is made on or before December 1, 1946.

IT IS FURTHER ORDERED that the Order in Decision No. 35936, dated November 5, 1942, shall remain in full force and effect, except as amended by this Second Supplemental Order.
