SECOND SUPPLEMENTAL OPINION

By Decision No. 36493, in Application No. 25683, a certificate was granted to Pacific Greyhound Lines authorizing the establishment and operation of a passenger stage service between San Diego, on the one hand, and Camp Miramar, Camp Linda Vista, and Camp Elliott, on the other hand. Service regulation No. 3 of the order of this decision, as amended by Decision No. 36660, describes the route to be used in providing service between these points:

In its second supplemental application, applicant requests authority to use Linda Vista Road between Old Town Junction and the intersection of Linda Vista Road and U. S. Highway 395 instead of its present route between these two points via Camino Del Rio and U. S. Highway 395 in order to avoid certain hazardous conditions at Old Town Junction. The proposed route would be two miles shorter than the present route. As applicant is not authorized to provide service at intermediate points on this route, the proposed rerouting will not deprive the public of any local service.

In our judgment the authority sought is in the public interest and will be granted. No public hearing is necessary.

SECOND SUPPLEMENTAL ORDER

Good cause appearing,

IT IS ORDERED that service regulation No. 3 of the order of Decision No. 36493, as amended by Decision No. 36660, is hereby deleted therefrom and the following substituted in lieu thereof:

"(3) Subject to the authority of this Commission to change or modify it at any time by further order applicant shall conduct said passenger stage service over and along the following route:

"Between the applicant's military station on First Avenue between Broadway and "C" Street, in San Diego, and Camp Miramar;

"Outbound: Via Front Street to "C" Street to Kettner Boulevard;

"Inbound: Kettner Boulevard to "C" Street to First Avenue to applicant's military station;

"Thence via Kettner Boulevard, La Jolla Avenue, San Diego Avenue, Taylor Street to Old Town Junction (intersection of Taylor Street and Camino Del Rio); thence via the New Linda Vista Road and U. S. Highway 395 through Camp Elliott and Camp Linda Vista to Camp Miramar."

IT IS FURTHER ORDERED that said Decision No. 36493 and said Decision No. 36660, shall in all other respects remain in

full force and effect.

The effective date of this order shall be the date hereof.
