BY THE COMMISSION:

<u>OPINION</u>

In this application Inglewood City Lines, a corporation, requests authority to provide a passenger stage service between Inglewood and the northerly entrance to the Los Angeles Municipal Airport. Applicant now holds a certificate to provide service between Inglewood and the Los Angeles Municipal Airport serving the southerly entrance thereto, which is situated approximately one mile southerly of the northerly entrance (Decision No. 36351, Application No. 25483). In conducting this service one of the streets used is Inglewood-Redondo Road between Arbor Vitae Street and Imperial Highway. The extension sought to the northerly entrance to the Airport would be over Century Bouleverd between its intersection with Inglewood-Redondo Road and such entrance, a distance of approximetely one-half mile. Applicant's local one-way fare of 5-cents would be charged where no transfer is involved.

In support of the extension sought, applicant asserts in substance that it has been informed that all major airlines now using the facilities at Burbank Air Terminal will transfer their activities to the Los Angeles Municipal Airport in the near future,

and that the city of Los Angeles has planned to erect a terminal building and facilities and establish an entrance on Century Boulevard between Inglewood-Redondo Road and Sepulveda Boulevard. It is also stated that there are several industries established on Century Boulevard which would be better served under its proposed extension, for which it has received requests.

Los Angeles Transit Lines, the only other carrier in the field directly affected, has informed the Commission that it does not desire to protest the application. This is not a matter requiring a public hearing and the application will be granted.

Inasmuch as applicant already holds a certificate authorizing operations between Inglewood and Los Angeles Municipal Airport, the authority herein requested will be authorized by supplementing the routes described in the service regulations of Decision No. 36351, in Application No. 25483, to include a route over Century Boulevard between its intersection with Inglewood-Redondo Road and the northerly entrance to the Airport.


ORDER

Good cause appearing,

IT IS ORDERED:

(1) That the route described in paragraph b.of the service regulations of the order of Decision No. 36351, in Application No. 25483, is hereby supplemented by adding thereto the following language:

"Over and along Century Boulevard between its intersection with Inglewood-Redondo: Road and the northerly entrance to the Los Angeles Municipal Airport."

(2) That applicant shall comply with the provisions of General Order No. 79 and Fart IV of General Order No. 93-A by filing, in triplicate, and concurrently making effective, appropriate tariffs and time schedules within 60 days from the effective date hereof and on not less than 5 days' notice to the Commission and the public.

(3) That Decision No. 36351 shall in all other respects remain in full force and effect.
