Decision No. 37870

In the Matter of the Application of the SOUTHERN CALIFORNIA WATER COMPANY to consolidate the operations of two districts into one district to be known as the "Calipatria-Niland District" and to place into effect therein a uniform schedule of rates.

Southern California Water Company, a corporation, engaged in the business of supplying water service to twenty-nine communities in the State of California, asks the Commission for authority to consolidate the operation of the water systems serving the unincorporated town of Niland and Calipatria, Imperial County, into one operative district to be known as "Calipatria-Niland District" and to make effective therein the rates now being charged in Calipatria.

The company has given the requisite notice to the Office of Price
Administration of its application to the Commission for a rate adjustment.
A public hearing in this proceeding was held at Niland before

The water for the Niland system is purchased from the Imperial Irrigation District. It is received from the Imperial canal and passed through four settling basins where the water is treated for algae and the silt is removed. The clear water is transmitted through 6,800 feet of 8 and 10-inch pipe lines to the townsite where it is chlorinated and then distributed through 16,000 feet of mains

ranging from 4 to 1 inches in diameter. There are 107 consumers receiving service from this system, of which 103 are served on a flat rate basis and the remaining 4 at measured rates.

The flat rates at present in effect at Niland provide for a monthly charge of \$2.00 for a single residence, with an additional charge of \$1.00 for each single residence attached to the service. The measured rates provide for a monthly minimum charge of \$2.90 which entitles the users to 1,000 cubic feet of water and a reduction in charges with an increase in the quantity used.

The company's Calipatria system is located 8½ miles northerly from Niland. This system also obtains water from the Imperial Irrigation District. The water is treated and settled in the same manner as at Niland. There are 283 consumers served at Calipatria, of which 275 are supplied at flat rates and the balance at measured rates.

The flut rates at Calipatria provide for a monthly charge of \$2.90 for a six-room residence or less, including one toilet, one bath, and water for irrigating one lot not exceeding 60 x 150 feet. Additional charges are made according to use of water and kind of premises served. The company asks to have these rates made effective at Niland, as the measured rates and operating conditions are the same, and the operation of the two systems is directed by one local superintendent.

The application was filed as a result of an informal complaint filed with the Commission on September 12, 1944. The complaint was signed by 66 customers of the Niland system, alleging insufficient water pressure for domestic, cooler use and fire protection. The company made an investigation of the distribution system, which showed that the 4-inch feeder lines had become badly fouled by tuberculation and caused the low pressure conditions. The company proposes, if the increased rate is authorized, to replace the feeder lines with 770 feet of 6 and 8-inch pipe lines made from materials that are not subject to tuberculation. The investigation also showed that the friction loss through the

chlorinator at the edge of the townsite caused a further five-pound pressure loss. The company proposes to redesign the station and move it to the settling basins. The total estimated cost of these improvements is \$5,100.

The company states that while the requested rate will not provide any return on the investment, still it will provide an additional \$1,100 annual revenue that will make it possible to install the proposed distribution facilities in Niland and thereby improve the service to its customers in that town.

The evidence shows that the book cost of the fixed capital installed in the Niland system, as of December 31, 1944, totaled \$44,286. The reserve for accrued depreciation was shown to be \$12,000, resulting in a net book cost of \$32,286. The operating revenues for the year 1944 were \$4,221. At the proposed Calipatria rates, the revenues were estimated to be \$5,450. The operating expenses during the same period were \$5,525, which included \$1,190 for depreciation, computed by the straight line method. The results of operation for the year by the application of the present or the proposed rate schedule, shows a loss for the Niland system.

The Calipatria system has a book cost of \$69,331, as of December 31, 1944. The accrued depreciation, as of the same date, is \$29,912, leaving a net book cost of \$39,419. The total 1944 revenues were \$12,953 and the operating expenses totaled \$12,313. This latter item includes an allowance of \$1,993 for depreciation, which was determined on a straight line basis. The result of 1944 operations of the Calipatria system shows a net revenue of \$280. When combined with the Niland system and applying the uniform rate to both properties, the 1944 operations still show a loss.

The Niland system lost the Southern Pacific Lines as a customer during January, 1944. The railroad company installed its own facilities for treating and delivering water for its own uses. Prior to the discontinuance of this service, the Niland system was a profitable one and enabled the company to furnish water to its domestic and commercial consumers at a lower rate than at Calipatria. However,

the company expects to promote some economy and efficiency by consolidating the two properties in so far as bookkeeping and accounting are concerned.

Representatives of the consumers objected to an increase in the rates, but they desired improved service and recognized the necessity of the company obtaining sufficient revenue to provide at least bare operating costs. They asked that the records of the two systems be kept separately in order that an examination into the reasonableness of the rates could be made in the future, if conditions justified such an action.

The evidence further shows that some of the flat rates being charged for service furnished in Calipatria were not filed with the Commission. These charges had apparently first been made, but not filed by the company's predecessor, Imperial Utilities Corporation. However, the charges have been continued in effect since 1929 when applicant acquired the system. The filed schedules also contained flat rate charges for services that are not now being supplied, such as water furnished for horses, stock, etc. The company asks to have the obsolete items removed from the schedules, but asks to include the charges being made but not shown on the filed tariff sheets.

It is apparent that the increased rates for the Niland system should be granted. The suggested changes in the Calipatria rate schedule will not result in any increases in charges to the consumers on that system, but will make it correspond to the charges now being made. The consolidation of the two systems into one operating unit will result in some economies and it appears to be in the public interest to grant the authority sought. However, in fairness to the consumers of both systems, the company will be expected to make the proposed additions to the Niland system and to keep its operation records in such a manner that it will enable the Commission to make a separate study of the reasonableness of the rates in either community.

ORDER

Application as entitled above having been filed with the Railroad Commission, a public hearing having been held thereon, the matter having been duly submitted and the Commission being fully advised in the premises,

IT IS HEREBY FOUND AS A FACT that the rates now charged by the Southern California Water Company, a corporation, for water supplied to its consumers in Niland, an unincorporated community, and Calipatria, an incorporated city, both in the County of Imperial, are unjust and unreasonable in so far as they differ from the rates herein established, and that the rates herein established are just and reasonable rates for the service rendered, and basing its Order upon the foregoing finding of fact and upon further statements of fact contained in the Opinion which precedes this Order,

IT IS HEREBY ORDERED that Southern California Water Company, a corporation, be and it is hereby authorized and directed to file in quadruplicate, in conformity with this Commission's General Order No. 96, with the Railroad Commission, not less than ten (10) days prior to the effectiveness thereof, the following schedule of rates to be charged for all service rendered on and after the first day of June, 1945:

- 5. Special rate schedule applicable to Niland School, Niland; California, filed October 19, 1937; by Southern California Water Company.

IT IS HEREBY FURTHER ORDERED that Southern California Water Company be and it is hereby authorized to consolidate the operations of the Niland system and the Calipatria system into one operating district to be known as the "Calipatria-Niland District."

For all other purposes, the effective date of this Order shall be twenty (20) days from and after the date hereof.
