OPINION

A. J. Chapin and Ione C. Chapin, his wife, d/b/a Caltransit, ask permission to issue to The Capital National Bank of Sacramento their promissory note for \$15,237.90 and execute a mortgage of chattels to secure the payment of the note. A copy of the proposed note and a copy of the proposed mortgage of chattels are on file in this application.

Applicants are the owners of an automotive passenger stage line operating under the name and style of Caltransit, rendering general passenger stage service in and around Salinas.

Applicants propose to purchase two 27-passenger new 1945 Ford Transit Buses at a cost of \$12,852.64. To pay for the buses applicants ask permission to issue to The Capital National Bank of Sacramento their promissory note for \$15,237.90. This includes the cost of the buses and prepaid interest of \$1,385.26. The note is payable in thirty monthly installments

of \$507.93, the first payment being due on June 15, 1945, and final payment on November 19, 1947. The prepaid interest is calculated at the rate of four per cent per ennum.

Applicants report that they need the two new buses to replace obsolete and worn-out equipment and to enable them to handle more efficiently the volume of traffic.

ORDER

The Commission has considered applicants' requests and is of the opinion that this is not a matter on which a hearing is necessary; that the money, property or labor to be procured or paid for through the issue of said note is reasonably required by applicants for the purposes herein stated and that this application should be granted as herein provided; therefore,

IT IS HEREBY ORDERED as follows:

- 1. A. J. Chapin and Ione C. Chapin, his wife, d/b/2 Caltransit, may, after the effective date hereof and on or before September 30, 1945, issue to The Capital National Bank of Sacramento their promissory note in the sum of not exceeding \$15,237.90 and execute a mortgage of chattels to secure the payment of said note, said note and said mortgage of chattels to be in substantially the same form as the note and mortgage of chattels on file in this application.
- 2. A. J. Chapin and Ione C. Chapin, his wife, d/b/a Caltransit, shall use the proceeds realized through the issue of

Said note to pay the cost of two 27-passenger new Ford Transit ... Buses and the interest referred to in this application.

- 3. The authority herein granted will become effective when applicants, or either of them, have paid the fee prescribed by Section 57 of the Public Utilities Act.
- 4. Within thirty (30) days ofter the issue of said note and the execution of said mortgage of chattels, A. J. Chapin and Ione C. Chapin, his wife, d/b/a Caltransit, shall file with the Railroad Commission a true, correct and complete copy of the note issued and of the mortgage of chattels executed under the authority herein granted, together with a statement showing the purpose for which they expended the proceeds realized through the issue of said note.
