OPINION

By Decision No. 36351 in Application No. 25483, Inglewood City Lines was authorized, among other things, in Section III (3) (c), to operate passenger stage service along Trunton Avenue, 82nd Street, Oreydon Avenue, 79th Street, Truxton Avenue, 83rd Place, Naylor Street, 84th Place, and Sepulveda Boulevard.

By Application No. 26756 applicant requests authority to modify and change this route due to the fact that 75th Street has recently been extended and improved and opened to public travel between Sepulveda Boulevard and Truxten Avenue, and alleges that by using the improved section of 75th Street as part of the loop of its Leyeld University-Merningside Meter Coach Route No. 2, it would permit the coaches to operate on a shorter and more regular route than by using the present circuitous one; furthermore, this change would place local transportation service closer to the people in the Kenweed area west of Sepulveda Boulevard and north of Manchester Avenue.

It appoars that this is not a matter in which a public hearing is mocessary and that the application should be granted.

ORDER

IT IS HEREBY ORDERED that sorvice regulation in Section III (3) (c) of Decision No. 36351 be and it is hereby amended to read as follows:

Boginning at the intersection of Manchester Avenue and Loyela Boulevard (Loyela University), thence along Loyela Boulevard, thence across University Campus to Fordiam (c) Road, thence along Fordham Road, Manchester Avenue, Manchester Boulevard, Cronshaw Boulevard, 90th Street, Second Avenue, Manchester Boulevard, Byrd Avenue, 24th Place, Third Avenue, 81st Street, Fifth Avenue, 77th Street, Eighth Avenue, and Cronshaw Boulevard to 1ts intersection with Manchester Boulevard.

Beginning at the intersection of Manchester Avenue and Truxton Avenue, thence along Truxton Avenue, 79th Street, and Sopulveda Beulevard to its intersection with Manchester Avonuo.

IT IS HEREBY FURTHER ORDERED that pormission and authority is granted to Inglowcod City Lines to discontinue its service ever the following described streets:

On Sith Place, between Sepulveda Boulevard and Naylor Avenue On Naylor Avenue between Sith Place and Sord Place On Sord Place between Naylor and Truxton Avenues On Sord Street between Truxton and Croyden Avenues On Croyden Avenue between 82nd and 79th Streets On 79th Street between Croyden and Truxton Avenues
