- (c) For a cortificate of public convenience and necessity to operate motor coach service on American and on El Dorado Streets, between Main and Market Streets.

In this application Stockton City Lines, Inc. proposes to consolidate its Southeast-Southwest Motor Coach Line No. 5 with its Stockton-Army Air Training Field (1)
Motor Coach Line No. 7-

Applicant alleges that by consolidating these lines, as proposed, the duplicute services now performed by the two lines between the business section of the City

of Stockton and the intersection of 8th Street and Sharps Lane will be eliminated and result in a substantial reduction of bus miles operated. In order to accomplish this applicant will require authority to operate on American Avenue and El Dorado Street between Market Street and Main Street, and obtain certificates on the pertions of the streets hereinafter described

It appears that the change in service herein proposed will serve public convenience and necessity, that this is not a matter in which a public hearing is necessary, and that the request should be granted.

ORDER

IT IS HEREBY ORDERED:

- I. That Stockton City Lines, Inc. is authorized to operate motor coaches along American Avenue and El Dorado Street between Market Street and Main Street in the City of Stockton in coordination with the remainder of its motor coach system.
- II. That Stockton City Lines, Inc. is hereby authorized to abandon motor coach service concurrently with the consolidation of its Southeast-Southwest Line and Army Air Training Field Line along the following described structs:

On 8th Street between Sacramento Street and Sharps Lane

On Chartor Way botween Sharps Lane and Pilgrim Street

On Pilgrim Street botwoon Chartor Tay and Main Street

On Main Street between Pilgrim Street and Stanislaus Street

On Markot Street between American Street and El Dorado Street.
