## SUPPLEMENTAL ORDER

By the above-numbered supplemental application, Pacific Electric Railway Company seeks the Commission's authority to make a slight modification of the route of its Long Beach-Pasadena Motor Coach Line in the City of Pasadena, so as to effect a relocation of its terminal in that city, from Marengo Avenue and Green Street to a location at Union Street and Fair Oaks Avenue.

As justification for this request, applicant alleges that it has in the past employed the Asbury Rapid Transit terminal at Marengo Avenue and Green Street for its Pasadena terminus and that Asbury Rapid Transit System has announced its intention to discontinue this bus facility as of July 31, 1945. Applicant now maintains a ticket office and waiting room in connection with its rail operations, located at Union Street and Fair Oaks Avenue, and through a slight extension of its Long Beach-Pasadena Motor Coach route, this latter terminal can be made available for the motor coach line.

The City of Pasadena has set aside curb space for this motor coach loading and it appears that all interested parties are

agreeable to the proposed change in station facilities, and that the request is reasonable and should be granted; therefore,

IT IS HEREBY ORDERED that Pacific Electric Railway Company is authorized to extend its Long Beach-Pasadona Motor Coach Line from the intersection of Colorado Street and Marengo Avenue along Colorado Street, Delacy Street, Union Street and Raymond Avenue to the intersection of Raymond Avenue and Colorado Street in the City of Pasadena; and concurrently abandon operations of this line between the intersection of Colorado Street and Marengo Avenuo and the intersection of Green Street and Los Robles Avenue along Marengo Avenue and Green Street in the City of Pasadona; and coincident with the establishment of service ever this new section of the line, the authority to operate over Marengo Avenue and Groen Street botwoon the intersection of Marengo Avenue and Colorado Street and Green Street and Los Robles Avenue, as authorized by Decision No. 32167, dated July 18, 1939, is hereby revoked and annullod.

Insofar as is necessary to conform to the rules of this Commission, applicant shall revise its tariffs, time tables, rules . and regulations in conformance with the authorization herein granted.

This order shall be effective immediately.
