In this first supplemental application it is alleged that a need has arisen for the extension of applicant's transportation service to and from an additional point in the city of Los Angeles, to wit: Chapman Park Hotel, located at 615 South Alexandria Avenue, Los Angeles, and applicant requests that the order in Decision No. 37375 be amended to include service to and from said hotel.

(1) That Paragraph (2) of the order in said Decision No. 37375 be amended to read as follows:

That a certificate of public convenience and necessity is hereby granted to Joe Ferrant authorizing the establishment and operation of service as a passenger stage corporation, as defined in Section 27 of the Public Utilities Act, for the transportation of passengers and their baggage between airline ticket offices or hotels located at 501 West Sixth Street, 508 West Sixth Street, 512 West Sixth Street, 516 West Sixth Street, 515 South Olive Street, 639 South Commonwealth Avenue, 3400 Wilshire Boulevard, 1634 North Vine Street, 1637 North Vine Street, 1714 Ivar Avenue, 6201 Sunset Boulevard, 7000 Hollywood Boulevard, and 615 South Alexandria Avenue (Chapman Park Hotel), all in the city of Los Angeles, on the one hand, and, on the other hand, Grand Central Air Terminal, Glendale; Los Angeles Municipal Airport, Los Angeles; and Lockheed Air Terminal, Burbank; and between Grand Central Air Terminal, Glendale; Los Angeles Municipal Airport, Los Angeles; and Lockheed Air Terminal, Burbank. The service to be performed hereunder shall be limited to the transportation of airline passengers and their baggage.

(2) That in all other respects said Decision No. 37375

shall remain in full force and effect.
