In this application, Los Angeles Transit Lines asks permission to abandon and sell or otherwise dispose of a parcel of real property formerly used as a portion of applicant's South Park Shops, located at Fifty-fourth Street and Avalon Boulevard, in the City of Los Angeles, California, and more particularly described as follows:

measuring 665" in depth on 53rd and 54th Streets starting from the property line on the west side of Avalon Boulevard with a width of 263", and including all improvements thereon."

The improvements referred to consist of two brick buildings, including repair shops, machine shops, overhaul, shops, store-rooms and offices, cranes, switch boxes, floor scales, boilers, etc. The evidence shows that the repair work that has heretofore been done in said buildings can be more economically carried on in other portions of applicant's South Park Shops or in other shops of applicant. The order herein will grant applicant's request. The investment in such property should be transferred from road and equipment accounts to account 404--Miscellaneous physical property. If applicant sustains any loss upon the sale of the property, it will charge such loss to a profit and loss account and not to an operating expense account.

ORDER
