## FIRST SUPPLEMENTAL ORDER

. . . . . . . . . . . . . .

By Decision No. 38235, dated September 25, 1945, in the above entitled matter, the Railroad Commission, among other things, authorized San Gabriel Valley Water Company to execute a trust indenture in, or substantially in, the same form as the trust indenture filed in this application as Exhibit "1", and to acquire all of the outstanding stock of Fontana Domestic Water Company at a cost of \$96,000 and assume indebtedness of that company in the amount of \$254,000.

At the time of the hearing held on the original petition herein, applicant filed with the Commission as Exhibit "1" a galley proof of its proposed trust indenture. In a supplemental

petition filed on October 19, 1945, it has advised the Commission that it has made certain changes in the language of the indenture. It has filed a copy of said indenture in its final form. We have no objections to the changes made by applicant. This order will authorize San Gabriel Valley Water Company to execute a trust indenture in form similar to that filed in this application on October 19th.

In connection with the acquisition by San Gabriel Valley Water Company of the outstanding stock of Fontana Domestic Water Company, it appears that under the agreement, dated July 9, 1945, providing for the transfer of such stock, the basic price of \$96,000 will be adjusted for certain current and accrued items on or about the time of actual transfer. Applicant reports that some question has been raised as to its authority under the order of the Commission to complete the transaction, no reference being made in such order relating to the adjustment of the purchase price. Accordingly, it has requested the Commission to amend its order so as to permit it to make the purchase price adjustment.

The Commission has considered the supplemental petition and is of the opinion that a further hearing is unnecessary and that applicant's request should be granted, therefore,

IT IS HEREBY ORDERED that San Gabriel Valley Water Company may execute a trust indenture in, or substantially in, the same form as that filed with the Commission on October 19, 1945, attached to the first supplemental petition herein, in lieu of the form of trust indenture originally filed in the proceeding as Exhibit "1".

IT IS HEREBY FURTHER ORDERED that Raragraph 2 of the order in Decision No. 38235, dated September 25, 1945, be, and it hereby is, amended to read as follows:

"2. San Gabriel Valley Water Company may, after the effective date hereof and on or before December 31, 1945, acquire all of the outstanding stock of Fontana Domestic Water Company at a cost of \$96,000, subject to adjustments as provided in the contract of date July 9, 1945, between Fontana Farms Company and R. H. Nicholson filed in this proceeding as exhibit "7", and assume indebtedness of Fontana Domestic Water Company in the amount of \$254,000."

IT IS HEREBY FURTHER ORDERED that Paragraph 4 of the order in Decision No. 38235, dated September 25, 1945, be, and it hereby is, amended to read as follows:

"4. San Gabriel Valley Water Company may issue and sell, on or before December 31, 1945, at not less than their face value and accrued interest, \$600,000 of first mortgage, 3-3/8% sinking fund bonds, Series A, due September 1, 1970. The proceeds, other than accrued interest, obtained from the sale of the bonds, shall be used for the following purposes:

To pay outstanding bonds of San Gabriel Valley Water Service, approximately	\$186,100
To pay notes and other indebtedness of Fontana Domestic Water Company,	254,000
To pay for stock of Fontana Water Company, about	96,000
To pay expenses of bond issue and expenses incident to this appli- cation, about	13,900
For additions and betterments or the acquisition of properties, as may hereafter be authorized by a supplemental order or orders, about	50,000
Total	\$600,000

The accrued interest may be used for general corporate purposes."

IT IS HEREBY FURTHER ORDERED that the order in Decision No. 38235, dated September 25, 1945, shall remain in full force and effect, except as modified by this First Supplemental Order.
