FIRST SUPPLEMENTAL OPINION AND ORDER

By Decision No. 38362, rendered October 30, 1945, in Application No. 26908, the Commission granted to Rex White a license to engage in the business of a motor carrier transportation agent. Such license expires December 31, 1945, and is renewable, subject to the provisions prescribed by the Commission.

White has now filed an application for a renewal of said license and the application will be granted. At the same time he has signified his intention to change the address at which he proposes to do business from 2251 West Pico Street, Los Angeles, to 626 South Alvarado Street, Los Angeles. A public hearing is not deemed necessary.

Good cause appearing,

IT IS ORDERED that Rex White is hereby licensed to engage in the business, or act in the capacity of a motor carrier transportation agent, as defined in the Motor Carrier Transportation Agent Act (Chapter 390, Statutes 1933, as amended), only at the following location, to wit: 626 South Alvarado Street, Los Angeles, California; to sell, offer for sale, negotiate for, furnish or provide transportation to destinations within the state of California only.

IT IS FURTHER ORDERED that Decision No. 38362, by which Rex White is licensed to operate as a motor carrier transportation agent at 2251 West Pico Street, Los Angeles, California, be and it is

hereby amended to provide that said Rex White is licensed to operate as such agent at 626 South Alvarado Street, Los Angeles, California.

IT IS FURTHER ORDERED that this license shall expire on December 31, 1946, subject to the provisions for renewal prescribed by the Railroad Commission; provided, however, that this license shall be inoperative and of no force or effect during any period when there shall not be in effect and on file with the Railroad Commission a good and sufficient surety bond provided by the licensee in accordance with the provisions of Section 8 of said Act and the rules and regulations of the Railroad Commission.

IT IS FURTHER ORDERED that the Secretary of the Railroad Commission be and he is hereby authorized and directed to issue and deliver to said Rex White a License Certificate of the authority granted hereby.

IT IS FURTHER ORDERED that the above described license be issued upon the condition that operations authorized thereunder shall be conducted in accordance with all applicable rules, regulations and requirements relating thereto issued by the Commission under the Motor Carrier Transportation Agent Act (Statutes 1933, Chapter 390, as amended).

The effective date of this order shall be the date hereof.
