## OBINION

In this application Helen W. Gasaway is requesting a license authorizing her to engage in the business of a motor carrier transportation agent, as defined in the Motor Carrier Transportation Agent Act (Chapter 390, Statutes 1933, as amended). Public hearing was held before Examiner Gannon at Los Angeles on November 30, 1945.

Applicant will establish headquarters at 9500 State Street, South Gate, California. She is 34 years of age and is the owner of a service station located at that address. Prior to engaging in that business she was employed by California Shipyards at Terminal Island.

It was stipulated at the h-aring that, in so far as applicable, the testimony of this applicant would be identical with that offered by applicant Webb in Application No. 27094. Both applicants have entered into a copartnership arrangement for the conduct of the business, though each will be individually licensed.

Applicant appears to be a law abiding person who understands the obligations that she will be required to assume as a motor carrier transportation agent and who is prepared lawfully to discharge her duties as such agent.

After due consideration of all the facts of record in this matter, the Commission is of the opinion and finds that this applicant should be licensed as a motor carrier transportation agent at the above mentioned address, and accordingly such license will be issued to her.

## ORDER

A public hearing having been held in the above entitled proceeding, evidence having been received, the matter having been submitted and the Commission now being fully advised in the premises

IT IS ORDERED that Helen W. Gasaway be and she is hereby licensed to engage in the business or act in the capacity of a motor carrier transportation agent, as defined in the Motor Carrier Transportation Agent Act (Chapter 390, Statutes 1933, as amended), only at the following location, to-wit: 9500 State Street, South Gate, California; to sell, offer for sale, negotiate for, furnish, or provide transportation to be furnished by motor carriers, as defined in Chapter 390, Statutes 1933, as amended, subject to the condition, however, that she shall, within sixty (60) days from the date hereof, provide and file with the Railroad Commission a good and sufficient surety bond in the sum of one thousand dollars (\$1000) in accordance with the provisions of Section 8 of said Act and in a form prescribed or approved by the Railroad Commission.

IT IS FURTHER ORDERED that this license shall expire on December 31, 1946, subject to the provisions for renewal prescribed

by the Railroad Commission; provided, however, that her license shall be inoperative and of no force or effect during any period when there shall not be in effect and on file with the Railroad Commission for said Helen W. Gasaway a good, and sufficient surety bond in accordance with the provisions of said Section 8 of said Act and the rules and regulations of the Railroad Commission.

IT IS FURTHER ORDERED that upon said Helen W. Gasaway filing with the Commission a surety bond as hereinabove provided, the Secretary of the Railroad Commission be and he is hereby authorized and directed to issue and deliver to said Helen W. Gasaway a certificate of the authority granted hereby.

IT IS FURTHER ORDERED that the above described license be issued upon the condition that operations authorized thereunder shall be conducted in accordance with all applicable rules, regulations and requirements relating thereto issued by the Commission under the Motor Carrier Transportation Agent Act (Statutes 1933, Chapter 390, as amended).

The effective date of this order shall be twenty (20) days from the date hereof.
