FIRST SUPPLEMENTAL OPINION

On August 14, 1945, the Commission issued Decision No. 38153 which granted a certificate to Joe West authorizing the transportation of property, excepting bulk liquids in tank trucks, explosives and commodities requiring special equipment, between Los Angeles, Zone 1, described in Item No. 30-A, as shown in Appendix "A" of the Commission's Decision No. 31605, Case No. 4246, on the one hand, and Needles and points intermediate to Needles and Daggett and also the military installation at Freda on the other hand. Such certificate bears an expiration date of March 1, 1946, unless extended by further order of the Commission.

On February 13, 1946, Joe West requested an order of the Commission extending the authority granted by said Decision No. 38153 for a reasonable period. In support of such request the application states that the public need and use of applicant's service have materially increased since the granting of the certificate; that shippers at Los Angeles and merchants at Needles and other areas authorized to be served have a greater need for a highway common carrier transportation service than at the time

of the granting of the certificate and that during the two months period next preceding February 1, 1946, applicant served approximately 364 shippers.

The Atchison, Topeka and Santa Fe Railway Company and Railway Express Agency, Incorporated, which provide a common carrier service between the points involved have informed the Commission in writing that they would offer no objection to a temporary extension of the authority heretofore granted to applicant.

After due consideration of applicant's request, we believe that it should be granted for a temporary period ending July 1, 1946.

FIRST SUPPLEMENTAL ORDER

An application therefor having been filed and it being hereby found that public convenience and necessity so require,

IT IS ORDERED that the certificate heretofore granted to Joe West by Decision No. 38153 shall expire July 1, 1946 unless extended by further order of the Commission.

IT IS FURTHER ORDERED that applicant shall comply with the provisions of General Order No. 80 and Part IV of General Order No. 93-A by filing in triplicate, and concurrently making effective tariffs or supplements thereto and time tables satisfactory to the Commission within 60 days from the effective date hereof and on not less than one day's notice to the Commission and the public, reflecting the authority herein granted.

The effective date of this order shall be the date hereof.
