O P I N I O N

In Decision No. 37512, the Commission authorized certain changes in the route of applicant over its so-called Los Angeles-San Fernando Division via Riverside Drive. One of said changes authorized applicant to discontinue operation over Victory Place and Empire Avenue between the intersection of Victory Place and Burbank Boulevard and the intersection of Empire Avenue and Lincoln Street, and in lieu thereof to operate over the following route:

"Beginning at the intersection of Victory Place and Burbank Boulevard, thence over Broadway Street, San Fernando Road and Lincoln Street to the intersection of Lincoln Street and Empire Avenue."

Applicant avers that at the time the change in route was made it appeared that it was the most desirable one in that service area. This impression was based to a considerable extent on the assumption that Broadway extended the entire distance between San Fernando Road and Burbank Boulevard. It later developed that the revised route involved operating over Broadway Street, San Fernando Road, Leland Way and Front Street.

Applicant now requests that the route hereinabove described by said Decision No. 37152 be further changed so that in lieu of the route authorized by said Decision No. 37152, it be permitted to operate over and along the route described in the order

which follows.

The proposed rerouting is wholly within the city of Burbank. Applicant states it has served copies of this application on the city of Burbank, Burbank Chamber of Commerce and Burbank City Lines. A public hearing does not appear necessary.

**ORDER**

Good cause appearing,

IT IS ORDERED that the first ordering paragraph of Decision No. 37152, in Application No. 26165, be and it hereby is deleted, and that there be substituted in lieu thereof the following:

- "(1) That Asbury Transit System, a corporation, is hereby authorized to discontinue operations over Victory Place and Empire Avenue between the intersection of Victory Place and Burbank Boulevard and the intersection of Empire Avenue and Lincoln Street and in lieu thereof to operate over the following route:

"Beginning at the intersection of Victory Boulevard and Burbank Boulevard, thence via Burbank Boulevard to Front Street, thence via Front Street to Leland Way, thence via Leland Way to Broadway Street, thence via Broadway Street to San Fernando Road, thence to the city of San Fernando via applicant's regularly authorized route."

In all other respects Decision No. 37152 shall remain in full force and effect.

The effective date of this order shall be 20 days from the date hereof.
