In the Matter of the Application of D. MOYERS, doing business as MOYERS STAGES, for a certificate of public convenience and necessity to operate a passenger stage service between Fresno and Orange Cove and intermediate points.

D. Moyers presently operates a passenger stage service between Fresno and other points in San Joaquin Valley.

By the above entitled application he requests the Commission to issue to him a certificate of public convenience and necessity authorizing the transportation of passengers, baggage and shipments of express weighing not in excess of 100 pounds each on passenger carrying vehicles between Fresno and Orange Cove and intermediate points via Centerville, Minkler and Wahtoke. The distance between Fresno and Orange Cove over the proposed route of operation according to the application is approximately 38 miles, and the proposed one way and round trip adult fares between these points would be 75% and \$1.35 respectively, with a minimum fare of 10%. Fares between other points would be in proportion. Express rates now in effect between other points served by applicant would be applicable to points proposed to be served. Three daily round trips would be operated.

As justification for the authority sought the application states that there are many persons living at Centerville, Minkler, Wahtoke and Orange Cove, and along the proposed route of operation who are without public transportation; that many of these persons have petitioned applicant to seek authority to provide such service and that there is no other public transportation between such points.

After full consideration of applicant's request it is our judgment, and we so find that there is a public need for the operation proposed by applicant, and the application will be granted. No public hearing is necessary.

ORDER

An application therefor having been filed and it having been found that public convenience and necessity so require,

IT IS ORDERED:

(1). That a certificate of public convenience and necessity is hereby granted to D. Moyers, authorizing the establishment and operation of service as a passenger stage corporation, as defined in Section 2:1/4 of the Public Utilities Act, for the transportation of passengers and baggage, and shipments of express weighing not in excess of 100 pounds each on passenger carrying vehicles only, between Fresno and Orange Cove and intermediate points via Centerville, Minkler and Wahtoke as an extension and the enlargement of and consolidated with the operative right granted by Decision No. 28868 in Application No. 20397.

(2) That applicant in providing service pursuant to the certificate herein granted shall comply with the following service regulations:

- (a) Applicant shall file a written acceptance of the certificate herein granted within a period of not to exceed 30 days from the effective date hereof.
- (b) Within 60 days from the effective date hereof and on not less than 5 days notice to the Commission and the public applicant shall establish the service authorized and comply with the provisions of the General Orders Nos. 79 and 80 and Part IV of General Order No.93-A, by filing in triplicate and concurrently, making effective appropriate tariffs and time tables.

(c) Subject to the authority of the Commission to change or modify it by further order applicant shall conduct operations pursuant to the certificate herein granted over and along the following route:

Beginning at Fresno, thence along Ventura Ave., Reed Avenue, Central Avenue, Frankwood Avenue, Adams Avenue, Hill Avenue, Orange Avenue; terminating at Orange Cove.

Applicant shall turn his motor vehicles at termini or intermediate points, either in the intersection of the streets or by operating around a block contiguous to such intersection in either direction.
