Angeles Vista Boulevard, Valley Ridge Avenue, 54th Street, Crenshaw Boulevard, Slauson Avenue, Keniston Avenue, Gay Street, Hyde Fark Boulevard, Florence Avenue, Centinela Avenue, La Brea Avenue and Manchester Avenue to the intersection of Manchester Avenue and Hillcrest Boulevard; returning via Hillcrest Boulevard, Regent Street, La Brea Avenue, and thence via the reverse of the above route.

Manchester Motor Coach Line No. 54

Commencing at the intersection of Regent Street and La Brea Avenue (City of Inglewood), thence via Regent Street, Redondo Boulevard, La Brea Avenue, Manchester Avenue, Firestone Boulevard Long Beach Boulevard and Seville Avenue to off-street terminal at Seville Avenue and Palm Place (City of South Gate); returning via the reverse of the above route to the intersection of Manchester Avenue and Hillcrest Boulevard (City of Inglewood), thence via Hillcrest Boulevard and Regent Street to the intersection of Regent Street and La Brea Avenue.

In all other respects Decision No. 38471 shall remain in full force and effect.

The above authority is granted subject to the condition that applicant shall, within thirty (30) days, file its written acceptance of this permission.
