OPINION AND ORDER

Glendale City Lines, Inc., a corporation engaged in the operation of motor vehicles for the transportation of passengers in and about the City of Glendale, reports that in order to meet transportation requirements and to improve its service, it has purchased from GMC Truck & Coach Division, General Motors Corporation, six new "GMC" TD 3609 transit type 36 passenger diesel powered motor coaches for a total cost of \$79,951.44, which includes estimated freight charges of \$2,770.62.

In order to finance, in part, the purchase price, the company proposes to borrow from the Anglo-California National Bank of San Francisco the sum of \$72,000. to be represented by a note repayable in sixty equal consecutive monthly installments, plus interest at the rate of 2½% per annum. The payment of the note will be secured by a chattel mortgage, in the form set out in Exhibit "D" filed in this proceeding, covering the six new motor coaches. In addition, it will be guaranteed by Pacific City Lines,

Inc., the owner of all the outstanding stock of Glendale City Lines, Inc.

The Commission has considered this matter and is of the opinion that a public hearing is not necessary; that Glendale City Lines, Inc., should be authorized to execute a chattel mortgage and to issue a note, as herein provided; and that the money, property or labor to be procured or paid for through the issue of said note is reasonably required by applicant for the purpose specified herein, which purpose is not, in whole or in part, reasonably chargeable to operating expense or to income, therefore,

IT IS HEREBY ORDERED as follows:

1. Glendale City Lines, Inc., after the effective date hereof and on or before October 31, 1946, may execute a chattel mortgage in, or substantially in, the same form as that filed in this proceeding as Exhibit "D", and may issue a promissory note in the principal amount of \$72,000., payable in sixty equal consecutive monthly installments plus interest at the rate of 2-1/2% per annum, for the purpose of financing in part the cost of the six motor coaches referred to herein.

2. The authority herein granted will become effective when Glendale City Lines, Inc., has paid the fee prescribed by Section 57 of the Public Utilities Act, which fee is Seventy-two (\$72.00) Dollars.

3. Glendale City Lines, Inc., shall file with the Commission a report, or reports, of the issue of the note herein

authorized and of the disposition of the proceeds, as required by the Commission's General Order No. 24-A, which order, insofar as applicable, is made a part of this order.
