By Decision No. 35936, dated November 5, 1942, an extension of time December 1, 1944, A further extension of time from December 1, 1944 to December 1. 1946 was granted by Decision No. 37428, dated October 24, 1944.

Associated Telephone Company, Ltd. now seeks a further extension to December 1, 1947, since it now appears that the proposed changes cannot be made within the period allowed by the Railroad Commission's Order in Decision No. 37428, due to various governmental orders and restrictions relating to the use of telephone equipment and materials, and changed conditions necessitating revision of the original engineering plans for this project.

The Commission has considered this matter and is of the opinion that the extension of time in which the proposed changes may be effected, as requested by the Applicant, is justified and should be granted, and that this is not a matter in which a public hearing is necessary.

IT IS ORDERED that the paragraph of the Order in Decision No. 37428, dated October 24, 1944, reading:

"IT IS ORDERED that Associated Telephone Company, Ltd. after proper showing to the Railroad Commission that it has completed the installation of dial equipment in its Pomona exchange and is ready to replace all eight-party residence telephone service therein with four-party service at the rates proposed therein, and upon Supplemental Order of the Railroad Commission, may discontinue its eight-party residence service, provided such showing is made on or before December 1, 1946."
