any time, the authority will be limited to a period of one year and made subject to earlier cancellation, modification or extension by appropriate order of the Commission.

Therefore, good cause appearing,

IT IS HEREBY ORDERED that Edward P. White, Richard I. Prosser, Anthony E. Perry, Marie C. Brown and William N. Coey, doing business as C. A. Worth & Co., be and they are hereby authorized to transport drugs, drug sundries and liquors for Coffin-Redington Co. from San Francisco to Oakland, Alameda, San Leandro, Emeryville, Berkeley and Richmond at rates less than the minimum rates established by Decision No. 31606, as amended, in Case No. 4246, but not less than the minimum rates set forth in Item No. 810 series of San Francisco City Carriers' Tariff No. 1, subject to rules and regulations therein applicable in connection with such rates, plus bridge tolls.

IT IS HEREBY FURTHER ORDERED that the authority herein granted shall expire one (1) year from the effective date of this order, unless sooner cancelled, changed or extended by appropriate order of the Commission.
