By Decisions Nos. 38979 and 39183 applicant was authorized to establish and operate a passenger stage service between the City of Long Beach and Dominguez, in the County of Los Angeles, over and along a certain described route.

Applicant now seeks authority to reroute a portion of said route between the intersection of Santa Fe Avenue and 223rd Street and the intersection of Willow Street and Easy Avenue, by operating over 223rd Street, Delta Avenue, Wardlow Road, and Easy Avenue, instead of Santa Fe Avenue and Willow Street.

As justification for the proposed change applicant states that its affiliate, the Long Beach City Lines, now provides service between downtown Long Beach and Easy Avenue via the Willow Street Bridge and that, because said bridge is about to be closed, service along Easy Avenue, north of Willow Street, will not be possible. The proposed rerouting will enable applicant to provide service between Easy Avenue; north of Willow Street, on the one hand, and downtown Long Beach, on the other hand. That, although such rerouting will take applicant's Dominguez line off Santa Fe Avenue between 223rd Street and Willow Street, this portion of the route is also presently served by a line of the Long Beach City Lines so that passengers along Santa Fe Avenue will continue to have service.

No changes in fares or schedules are contemplated. The Bureau of Franchises and Public Utilities of the

City of Long Beach does not oppose the granting of this application.

The proposed route change being in the public interest, the application will be granted. A public hearing is not necessary.

IT IS HEREBY ORDERED that the route description appearing in Section I, paragraph (2), subparagraph (c) of the Order in Decision No. 38979, as amended by the Order in Decision No. 39183, be, and it hereby is, further amended to read as follows:

> Beginning at the intersection of First (1st) Street and American Avenue, in the City of Long Beach, thence along First (1st) Street, Locust Street, Ocean Boulevard, American Avenue, Pacific Coast Highway, Harbor Avenue, Twentieth (20th) Street, Easy Avenue, Wardlow Road, Delta Avenue, 223rd Street, Santa Fe Avenue, Carson Street, Harbor View Avenue, Dominguez Street, Prospect Avenue, Harrison Street to its intersection with Harbor View Avenue.

For all other purposes the Order in Decision No. 38979 shall remain in full force and effect.
