OPINION

In the above entitled application Bernard Alexander Gjerdrum requests a license authorizing him to engage in the business of a motor transportation broker pursuant to Chapter 705, Statutes of 1935.

A public hearing was held by Examiner Gannon at San Francisco on October 21, 1946, and the matter was submitted. No one appeared in protest to the granting of the application.

The applicant has, according to the record, complied with the essential routine statutory requirements in connection with motor transportation broker proceedings in that he has prepared and filed an application, surety bond, list of carriers and letters of authority from the carriers designating him as their duly authorized transportation representative.

The applicant herein is associated with John Joseph Shea as co-manager of the Brisbane office of Common Carriers' Auxiliary Corporation. The application of Shea (Application No. 27821) was heard at the same time as Gjerdrum's and was granted. It was stipulated at the hearing that the testimony of Gjerdrum, if received, would be substantially identical with that of Shea as

to the method of operation in which both applicants proposed to engage under their respective applications.

Applicant Gjerdrum graduated from Santa Clara University and entered the law department of that institution as a student in 1935. He was engaged in the teaching profession during 1941 and 1942, when he entered the military service of the United States. Upon his discharge from the Army he secured employment with the Golden State Company, Ltd., and associated himself with Common Carriers' Auxiliary Corporation in August of this year.

The applicant appears to be qualified to carry on the business for which he is seeking a license, and such license will accordingly be issued to him.

ORDER

A public hearing having been held in the above entitled proceeding, the matter having been duly submitted and the Commission being fully advised in the premises,

IT IS ORDERED that the application of Bernard Alexander Gjerdrum for a license as a motor transportation broker, as defined in Chapter 705, Statutes of 1935, be and it hereby is granted, and that such license be issued to said Bernard Alexander Gjerdrum subject to the following conditions:

- 1. That said lic-nsee shall keep his respective license certificate as motor transportation broker open at all times to public inspection.
- 2. That said licensee shall do business as a motor transportation broker only at the location set forth in his application for a license and for the motor carriers hereinafter named, or for whom he may hereafter from time to time be permitted to do business by any subsequent order or orders of the Commission.

IT IS FURTHER ORDERED that the license of said applicant shall authorize him to sell, offer for sale, negotiate for, furnish, or provide and hold himself out to sell, negotiate for, furnish or provide transportation of property over the public highways of this State to be furnished only by the carriers whose names, addresses and permit numbers follow, to-wit:
