OPINION AND ORDER

A.28041 - Gr

Harold Stephen Lundie was granted a license to engage in the business of a motor carrier transportation agent by Decision No. 38901, dated May 2, 1946, in Application No. 27262. The license expires December 31, 1946. On December 2, 1946, Lundie applied for a renewal of his license for 1947. He states that he will continue to do business at his present address, and in the manner described in his original application.

A license to engage in business as a motor carrier transportation agent is renewable only if filed not later than thirty days prior to the expiration date of the license sought to be renewed.

Applicant's present license will not be renewed. Instead, the application will be treated as one for a new license for the year 1947, and will be granted accordingly. A public hearing is not necessary.

Good cause appearing;

IT IS ORDERED that Harold Stephen Lundie be and he is hereby licensed to engage in the business or act in the capacity of a motor carrier transportation agent, as defined in the Motor Carrier Transportation Agent Act (Ch. 390, Stats. 1933, as amended),

only at the following location, to-wit: 843 Van Ness Avenue, San Francisco, California; to sell, offer for sale, negotiate for, furnish or provide transportation to be furnished by motor carriers, as defined in Chapter 390, Statutes 1933, as amended, subject to the condition, however, that he shall, within 60 days from the date hereof, provide and file with the Fublic Utilities Commission a good and sufficient surety bond in the sum of \$1,000 in accordance with the provisions of Section 8 of said Act and in a form prescribed or approved by the Fublic Utilities Commission.

IT IS FURTHER ORDERED that this license shall expire on December 31, 1947, subject to the provisions for renewal prescribed by the Public Utilities Commission; provided, however, that his license shall be inoperative and of no force or effect during any period when there shall not be in effect and on file with the Public Utilities Commission for said Harold Stephen Lundie a good and sufficient surety bond in accordance with the provisions of said Section 8 of said Act and the rules and regulations of the Public Utilities Commission.

IT IS FURTHER ORDERED that upon said Harold Stephen Lundie filing with the Commission a surety bond as hereinabove provided, the Secretary of the Public Utilities Commission be and he is hereby authorized and directed to issue and deliver to said Harold Stephen Lundie a certificate of the authority granted hereby.

IT IS FURTHER ORDERED that the above described license be issued upon the condition that operations authorized thereunder shall be conducted in accordance with all applicable rules, regulations and requirements relating thereto issued by the Commission
