SUPPLEMENTAL OPINION AND ORDER

By prior orders in these proceedings applicants, operating as public utility warehousemen in San Francisco and Oakland, were granted temporary certificates of public convenience and necessity to establish or increase warehouse space in amounts specified to meet requirements for storage of United States Government property and transshipment cargo awaiting assignment of vessel space. These authorizations are scheduled to expire December 31, 1946. Verified supplemental applications have been filed seeking a one year extension of these authorizations.

The supplemental applications show that conditions have not changed materially since this matter was last considered a year ago; that there are continuing demands for the storage space involved; and that petitioners are unable to determine how long the need for this

storage space will continue. It appears that this is a matter in which a public hearing is not necessary and that the sought extensions should be granted.

Therefore, good cause appearing,

IT IS HEREBY ORDERED that the expiration date of the authorizations granted applicants by Decision No. 33615, as amended, in Application No. 22695; Decision No. 33777, as amended, in Applications Nos. 23823, 23851, 23852 and 23857; Decision No. 35359, as amended, in Applications Nos. 24785, 24864 and 24892; Decision No. 37455, as amended, in Applications Nos. 24946 and 24947; Decision No. 36961, as amended, in Application No. 25983; and Decision No. 37886, as amended, in Application No. 26587, be and it is hereby extended to December 31, 1947, unless sooner changed or further extended by appropriate order of the Commission.

This order shall become effective January 1, 1947.
