(4) That these licenses shall expire, respectively, on December 31, 1947, subject to the provisions for renewal prescribed by the Public Utilities Commission; provided, however, that each of said licenses shall be inoperative and of no force or effect during any period when said licensees, respectively, shall not have on file with the Public Utilities Commission a good and sufficient surety bond in accordance with the provisions of Section 8 of said Act and the rules and regulations of the Public Utilities Commission:

(5) That the Secretary of the Public Utilities Commission be and he is hereby authorized and directed to issue and deliver to said licensees, respectively, certificates of the authority granted hereby.
