3RD SUPPLEMENTAL APPLICATION: For modification of Service Regulation in Decision No. 35763 to use additional route between Campbell and Los Gatos; Santa Clara County.)

O P I N I O N

Peerless Stages, Inc. by the above-entitled supplemental application requests authority to use an additional route intermediate to Campbell and Los Gatos in order to serve a newly developed residential area. Decision No. 35763 authorized applicant to conduct passenger stage service between Oakland, Santa Cruz and intermediate points, including Los Gatos and Campbell subject to the restrictions therein set forth. Such restrictions are not applicable to the portion of the route involved herein.

As justification for the authority sought the application states, in substance, that since the granting of Decision No. 35763 many homes have been built, and others are under construction along or near the additional route proposed. Applicant states that it has had many requests for the establishment of the proposed service. Applicant's local fares would be applicable to the proposed routing.

After full consideration it is our conclusion that there is a public need for the proposed operation and that no public hearing is necessary. No other common carrier would be affected by the proposed operation. The application will be granted.

ORDER

Good cause appearing,

IT IS ORDERED that Route No. 3 between San Jose, Los Gatos and Saratoga, as defined in Service Regulation No. 2 of the Order of Decision No. 35763, as amended by Decision No. 38828, is hereby further amended by adding thereto the following route:

"(g) Campbell to Los Gatos: Commencing at the intersection of Campbell Avenue and Los Gatos - Santa Clara Road, thence along said Los Gatos - Santa Clara Road, Sunny Oakes Road, Virginia Avenue, Hazel Avenue, San Tomas Aquino Road, Burrows Road, Pollard Road, San Tomas Aquino Road, Hacienda Avenue."

IT IS FURTHER ORDERED that applicant within 30 days from the effective date hereof and on not less than 5 days' notice to the Commission and the public shall file in triplicate and concurrently make effective time tables and such amendments to its tariffs as are necessitated by the addition of the above-described route.

IT IS FURTHER ORDERED that said Decisions Nos. 35763 and 38828 shall in all other respects remain in full force and effect.

The effective date of this order shall be the date hereof.
