## C B I Z I O Z

By Decision No. 39668 applicant, Bryan Bayly, was authorized to establish and operate a common carrier service for the transportation of persons and their hand baggage, by vessel, between Wilmington, in the City of Los Angeles, and Avalon, on Catalina Island.

As had been requested by applicant, the certificate was granted subject to a condition restricting the service to "a scasonal basis approximately from the first day of May to the thirtieth day of September each year".

By this first supplemental application authority is requested to perform said service by operating his "unscheduled trips" beginning approximately the first day of March of each year instead of the first day of May.

As justification for the proposed change applicant states that there are many occasions prior to May when persons desire to make the trip to Avalon on applicant's water taxis on so-called "unscheduled" trips.

"Unscheduled" trips, requiring a minimum of 10 passengers, leave Wilmington at 10:30 a.m., arriving at Avalon at 12:30 p.m., and leave Avalon at 4:00 p.m. and arrive at Wilmington at 6:00 p.m. These trips are offered to accommodate persons who reach the Catalina Terminal too late for departure on Wilmington Transportation Company steamships and, on rare occasions, to care for overflow steamship patrons.

No change in schedules is contemplated. Applicant's regular service will be operated as originally proposed. The proposed fares and service, and rules and regulations governing same, are the same as set forth in the tariff now on file with this Commission.

There is no protest to the granting of this application.

Upon consideration of this matter the Commission finds

that public convenience and necessity require the operation of
a water-taxi service as proposed and, therefore, the application

will be granted. A public hearing is not necessary.

## ORDER

Application having been made therefor and good cause appearing,

IT IS ORDERED:

That service regulation (a) of paragraph (2) of the Order in Decision No. 39668, dated November 26, 1946, be, and it hereby is, amended to read as follows:

(a) That the common carrier service herein authorized shall be performed on a seasonal basis approximately from the first day of March to the thirtieth day of September, each year.
