NINTH SUPPLEMENTAL OPINION AND ORDER

Blake W. Palamountain, formerly associated with Common Carriers Auxiliary Corporation in Oakland as a motor transportation broker, has terminated his relationship with that organization. By this application he requests an amended license to conduct his brokerage business in San Leandro. He has submitted the names of carriers for whom he proposes to solicit business, pursuant to letters of authority now in the Commission's files, and has also filed the required bond.

Rather than issuing an amended license, a new license will be granted to applicant as an individual broker. A public hearing is not necessary.

Therefore, good cause appearing, IT IS ORDERED that the application of Blake W. Palamountain for a license as a motor transportation broker, as defined in Chapter 705, Statutes of 1935, be and the same is hereby granted, and that such license be issued to said applicant subject to the following conditions:

That said licensee shall keep his license certificate as motor transportation broker open at all time to public inspection.

2. That said licensee shall do business as a motor transportation broker only at the location set forth in his application for a license and for the motor carriers hereinafter named, or for whom he may hereafter from time to time be permitted to do business by any subsequent order or orders of the Commission.

IT IS FURTHER ORDERED that the license of said applicant shall authorize him to sell, offer for sale, negotiate for, furnish or provide and hold himself out to sell, negotiate for, furnish or provide transportation of property over the public highways of this state to be furnished only by the carriers whose names, addresses and permit numbers follow, to-wit:
