## SIXTH SUPPLEMENTAL OPINION AND ORDER

Applicant has been authorized to transport bakery goods for National Eiscuit Company and Sunshine Eiscuits, Inc. (formerly Loose-Wiles Eiscuit Company) at rates less than those prescribed as minima. Under such authority shipments are transported within San Francisco and Oakland and between those cities and other points along designated highway routes terminating at Willits, Calistoga, Suisun-Fairfield, Tracy and San Jose, at rates of 40 cents per 100 pounds, minimum weight 5,250 pounds, and 10 cents per mile for mileage travelled in excess of 50 miles per day.

The authority is scheduled to expire September 11, 1947. Applicant seeks a one-year extension and amendment thereof so as to provide increased rates of 50 cents per 100 pounds, minimum weight 5,250 pounds, and 11 cents per mile for mileage in excess of 50 miles per day based upon 21 working days per month.

In the verified supplemental application it is asserted that general conditions surrounding this transportation have not changed materially; that some increases in operating expenses have been experienced; that the higher rates proposed are sufficient to offset the increased operating expenses and to return a satisfactory profit; and that the traffic in question will be diverted to proprietary carriage unless the sought authority is granted.

It appears that this is a matter in which a public learing is not necessary and that the proposed rates should be authorized for a one-year period.

Therefore, good cause appearing,

IT IS HEREBY CRDERED that Walkup Drayage and Warehouse Company be and it is hereby authorized to transport bakery goods, viz.: biscuits, cookies, crackers, matzos, pretzels and toast for National Biscuit Company and Sunshine Biscuits, Inc. (formerly Loose-Wiles Biscuit Company) from San Francisco and Oakland to points within the area embraced by Application No. 24949, filed April 27, 1942, at rates less than the established minimum rates but not less than the basis of rates set forth in the sixth supplemental application filed August 15, 1947.

This authority shall expire one (1) year from the effective date hereof unless sooner changed, canceled or extended by order of the Commission.
