O P I N I O N

Pacific Electric Railway Company, by virtue of authority from this Commission, presently operates rail and motor-coach lines in Los Angeles, Orange, San Bernardino, and Riverside Counties. This company now seeks a certificate of public convenience and necessity authorizing modifications of two of its bus routes. It is proposed to change Route 2-C so far as certain routings in the City of Colton are concerned and also to change Route 4-D so as to add an alternate route in the City of Alhambra.

The route change in the City of Colton is necessary in order to comply with the traffic regulations prohibiting left-hand turns. Using the present routings applicant is required to make a left-hand turn at 8th and I Streets, one of the corners where such turns are prohibited. Under the proposed routing this is avoided.

The addition of the alternate route in the City of Alhambra is for the purpose of serving applicant's agency office at 47 South Garfield Avenue without going through congested traffic.

The City Attorney of Alhambra has agreed to the alternate route in Alhambra and the City Administrator of Colton has agreed to the route changes in that city. All carriers in the area have been contacted and none of them has indicated any opposition to the proposed changes.

According to the record applicant is willing and able to conduct the operation under the proposed changes.

The application will be granted. A public hearing is not necessary.

O R D E R .

Application as above entitled having been filed, the Commission being fully advised in the premises and hereby finding that public convenience and necessity so require,

IT IS ORDERED:

(1) That a certificate of public convenience and necessity be, and it hereby is, granted to the Pacific Electric Railway Company, a corporation, authorizing the establishment and operation of a service as a passenger stage corporation as that term is defined in Section 2½ of the Public Utilities Act, for the transportation of passengers, baggage, and express along the routes, and between the points hereinafter specified, in the cities of Colton and Alhambra, as an extension and enlargement of, and to be consolidated with, applicant's existing rights in said territory, as set out in Decision No. 38827, dated April 9, 1946, and specifically modifying Routes 2-C and 4-D, as set out therein.

(2) That in providing service pursuant to the certificate herein granted, the following service regulations shall be complied with:

- (a) Applicant shall file a written acceptance of the certificate herein granted within a period of not to exceed thirty (30) days from the effective date hereof.
- (b) Applicant shall, within sixty (60) days from the effective date hereof and upon not less than one (1) day's notice to the Commission and the public, establish the service herein authorized and comply with the provisions of General Order No. 79 and Part IV of General Order No. 93-A by filing, in triplicate, and concurrently making effective, tariffs and time schedules satisfactory to the Commission.
- (c) Subject to the authority of this Commission to change or modify such at any time, Pacific Electric Railway Company shall conduct said passenger stage operation over and along the following described routes:

Route 2-C

From 7th and Market Sts. (Riverside), via Market St., First St., Main St., Russell St., Redman Curve, La Cadena Drive, Colton Ave., 8th St. (Colton), "G" St., Colton Ave., "E" St. and 2nd St., to private driveway to Pacific Electric Railway depot between "E" and "F" Sts. (San Bernardino).

Route 4-D

From Valley Blvd. and Rosemead Blvd. (Rosemead), via Rosemead Blvd., Mission Drive, Las Tunas Drive (San Gabriel), Main St. (Alhambra), Garfield Ave., Atlantic Blvd., Wilson Ave., Los Robles Ave., Colorado St., Delacy St., Union St., and Raymond Ave. to Colorado St. (Pasadena). Also, from Main St. and Chapel St. (Alhambra), via Chapel St., Bay State Street and Garfield Ave. to Main St.

The effective date of this Order shall be twenty (20) days from the date hereof.
