SUPPLEMENTAL ORDER CORRECTING DECISION No. 40398

Decision No. 40398, issued on June 10, 1947 in the above mat-  
ter, involved two reroutings, one extension of service, and a one  
block abandonment of service, in connection with the operations of  
San Bernardino Valley Transit Company. The order therein issued  
a certificate between San Bernardino, on the one hand, and East  
Highlands and the Air Corps depot, on the other hand, and intermedi-  
ate points, as an extension and enlargement of the carrier's then  
existing operative rights. The order also provided that such certi-  
ficate should supersede the operative rights "granted to, or ac-  
quired by" applicant carrier, "pursuant to Decisions Nos. 34800,  
37279, and 39011, or orders amendatory thereof, which operative  
rights are hereby annulled and revoked." (Emphasis added.)

Under Decision No. 39011 (App. No. 27512), applicant carrier  
had acquired, as a result of a merger with Air Service Transit, Inc.,  
a restricted operative right between San Bernardino and Del Rosa,  
no passengers to be transported having origin and destination along  
Base Line Street between Mountain View and Del Rosa Avenues, both  
inclusive.

The San Bernardino-Del Rosa right was inadvertently revoked by inclusion of Decision No. 39011 in ordering paragraph (3) of the order in Decision No. 40398 in the present proceeding. It was not the Commission's intent to revoke that right. Such revocation was not an issue, and the Del Rosa right was neither involved nor discussed in Decision No. 40398.

Good cause appearing, IT IS ORDERED that Decision No. 40398 is hereby corrected, as of June 10, 1947, the date of the issuance of said Decision No. 40398, by deleting from ordering paragraph (3) of the order therein the phrase "pursuant to Decisions Nos. 34800, 37279 and 39011," and correcting said phrase to read "pursuant to Decisions Nos. 34800 and 37279."
