<u>O P I N I O N</u>

Gibson Lines has requested authority to use an alternate route between Marysville and Yuba City in conducting its operations between Marysville and Chico and intermediate points heretofore authorized by Decision No. 35292.

The application states that there has recently been constructed and opened for traffic a new bridge across the Feather River, to be known as the Marysville-Yuba City Bridge; that the purpose of this new bridge is to divert through traffic from the old bridge which crosses the Feather River at a point about five blocks south of the new bridge; and that the traffic congestion on the old bridge creates a hazard for applicant's buses which can be avoided by use of the new bridge.

Applicant's certificate which authorizes service between the points involved contains a restriction prohibiting local ser-(1) vice between Marysville and Yuba City except on through schedules.

The local carrier in Marysville has informed the Commission that he does not desire to protest the granting of this application if the authority granted is made subject to said restriction.

After full consideration it is our judgment that applicant's request is in the public interest and will be authorized by an amendment to the routes described in applicant's present certificate granted by said Decision No. 35292, which will render the use of the proposed alternate route subject to the applicable restrictions and conditions set forth in the order of said Decision No. 35292, as amended. No public hearing is necessary.

<u>ORDER</u>

Good cause appearing,

IT IS ORDERED:

(1) That the route of operations between Marysville and
Chico, as defined in paragraph 4(h) of the service regulations
of the order of Decision No. 35292 in Application No. 24889,
is hereby amended by adding thereto the following alternate
route between Marysville and Yuba City:

"Beginning at the intersection of Fifth and E Streets, Marysville, thence along E Street, 10th Street, Marysville-Yuba City Bridge, Summor Street (Yuba City), to its intersection with Plumas Street."

(2) That Decision No. 35292, as amended, shall in all other respects remain in full force and effect.

The effective date of this order shall be twenty days from the date hereof.
