### <u>O P I N I C N</u>

Pacific Hotor Trucking Company requests a certificate authorizing a highway common carrier operation between Sacramento and Carmichael, the latter point being located on Fair Oaks Boulevard approximately one-half mile south of the junction of Fair Oaks Boulevard and Manzanita Avenue. The route proposed to be used in providing this service would be Fair Oaks Boulevard between Sacramento and the junction of Fair Oaks Boulevard and Manzanita Avenue. No authority is sought to serve intermediate points along this route.

According to the application, this applicant is presently providing a highway common carrier service between Sacramento, Fair Oaks, Folsom and other points in the area, one of its routes being within approximately one-half mile of Carmichael. The rates proposed to be charged are those set forth in Exhibits C-1 and C-2 attached to the application. The application states that no highway common carrier provides service to or from Carmichael; that business establishments at Carmichael have requested applicant to extend its service, as proposed, to supply their transportation needs and that such extension would

eliminate the necessity of said business establishments operating their equipment to and from Fair Oaks and Sacramento to pick up shipments.

After full consideration we find that public convenience and necessity require the establishment and operation of the proposed service. No public hearing is necessary.

### $\underline{O} \underline{R} \underline{D} \underline{E} \underline{R}$

An application therefor having been filed, the Commission being fully advised in the premises and having found that public convenience and necessity so require,

IT IS ORDERED:

(1) That a certificate of public convenience and necessity is hereby granted to Pacific Motor Trucking Company authorizing the establishment and operation of service as a highway common carrier, as defined in Section 2-3/4 of the Public Utilities Act, for the transportation of property between Sacramento and Carmichael as an extension and enlargement of and consolidated with the operative right granted by Decision No. 26262 in Application No. 18727.

(2) Mat in providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:

> a. Applicant shall file a written acceptance of the certificate herein granted within a period of not to exceed 30 days from the effective date hereof.

- b. Within 60 days from the effective date hereof and on not less than 5 days: notice to the Commission and the public, applicant shall establish the service herein authorized and comply with the provisions of General Order No. 80 and Part IV of General Order No. 93-A, by filing in triplicate, and concurrently making effective appropriate tariffs and time tables.
- c. Subject to the authority of this Commission to change or modify it by further order, applicant shall conduct operations pursuant to the certificate herein granted over and along the following route:

Over and along Fair Oaks Boulevard between Sacramento and the junction of Fair Oaks Boulevard and Manzanita Avenue near Carmichael.

The effective date of this order shall be twenty days from the date hereof.
