## <u>O P I N I O N</u>

By this application, Pacific Greyhound Lines, a passenger stage corporation, seeks a certificate of public convenience and necessity authorizing operations over U. S. Highway 101-Pypass between its junction with First Street near San Jose and a point in the vicinity of Edenvale.

Applicant is authorized to operate via both U. S. Highway 101 and U. S. Highway 101-Pypass (also known as Bay Shore Highway) between San Francisco and San Jose and via U. S. Highway 101 south of San Jose. Decision No. 23244, dated December 31, 1930, in Application No. 16989 (35 C.R.C. 667, 677).

The Eypass has been extended approximately 12 miles to a connection with U. S. Highway 101 near Edenvale. Applicant proposes to operate over this newly constructed highway certain of its "Limited" schedules which do not serve San Jose. It is stated that by so doing some saving in running time will result and that traffic congestion on the main highway through San Jose will be avoided.

No protests against the granting of the application have been received. A public hearing does not appear to be necessary.

Upon the facts presented, the Commission finds that public convenience and necessity require the establishment and operation of

service by applicant over and along the recently constructed portion of U. S. Highway 101-Bypass from a point north of San Jose to a connection with U. S. Highway 101 near Edenvale, as proposed in the application in this proceeding.

## <u>o r d e r</u>

Application as above entitled having been made, the Commission being fully advised in the premises and having found that public convenience and necessity so require,

## IT IS ORDERED:

1. That a certificate of public convenience and necessity be and it is hereby granted to Pacific Greyhound Lines authorizing the establishment and operation of service as a passenger stage corporation, as defined in Section 2-1/4 of the Public Utilities Act, as an extension of and to be consolidated with its present operations for the transportation of passengers, baggage and shipments of express (not weighing in excess of 100 pounds each and transported on passenger vehicles only) over and along U. S. Highway 101-Eypass between the junction of said U. S. Highway 101-Eypass and First Street near San Jose and its connection with U. S. Highway 101 near Edenvale.

2. That in providing service pursuant to the certificate herein granted, Pacific Greyhound Lines shall comply with and observe the following service regulations:

- a. Applicant shall file a written acceptance of the certificate herein granted within a period of not to exceed 30 days from the effective date hereof.
- b. Applicant shall comply with the provisions of Tariff Circular No. 2, General Order No. 79 and Part IV of General Order No. 93-A by filing, in triplicate, and concurrently making

effective appropriate tariffs and time schedules within 60 days from the effective date hereof and on not less than 1 day's notice to the Commission and the public.
