OPINION AND ORDER

In this application Pacific Gas and Electric Company requests authorization to carry out the terms and conditions of an agreement with Basic Vegetable Products, Incorporated, dated May 26, 1948, providing for the sale and delivery of water to Basic's plant located on Stevenson Street, in the city of Vacaville. The water is to be delivered through a 3-inch service pipe at a rate not exceeding 325 gallons per minute, is to be limited by a load limiting device to that maximum flow, and is to be paid for at the following rate:

- Service Charge Seventy-five Dollars (\$75.00) per month for delivery of 325 gallons per minute or less.
- Commodity Charge (to be added to Service Charge) Seven and one-half cents (\$0.075) per 1,000 gallons.
- Minimum In no event shall the combined total of the Service and Commodity Charges be less for any month than an average of ten cents (\$0.10) per 1,000 gallons.

The agreement further provides that in the event it becomes necessary to adjust, by agreement, for a delivery of other than 325 gallons per minute maximum, the service charge shall be increased or

decreased by 30 cents per gallon per minute in accordance with the water delivery.

The Commission having considered the request of the applicant and being of the opinion that the application should be granted, that a public hearing in this matter is not necessary, and good cause appearing, therefore,

IT IS HEREBY ORDERED as follows:

1. Pacific Gas and Electric Company be and it is hereby authorized to carry out the terms and conditions of a written agreement dated May 26, 1948, with Basic Vegetable Products, Incorporated, which is attached to the application as Exhibit "A" and made a part hereof by reference.
2. Pacific Gas and Electric Company shall file with this Commission within sixty (60) days two (2) certified copies of the agreement as consummated.
3. Pacific Gas and Electric Company shall notify this Commission of the date of termination of said agreement within thirty (30) days thereof.

The effective date of this Order shall be twenty (20) days from and after the date hereof.
