OPINION AND CRDER

In this application Pacific Gas and Electric Company asks for authority to carry out the terms and conditions of a contract with Annabel Bauman, operator of the Sonora Hospital, dated June 18, 1948. Said agreement provides for the supply of water for use in the operation of an overhead sprinkling system installed in the Sonora Hospital at 1302 Washington Street, Sonora, which sprinkler system will be used only in the event of fire. The contract provides for a 4-inch service connection from Pacific Gas and Electric Company's existing; 6-inchwater main and the making available to the sprinkler system of such water at such pressure as may be available at the point of delivery as a result of Pacific Company's normal operation. Pacific Company is not required to reserve capacity in said water main or in its distribution system, or to increase its water supply, or mains, or pressure for the purpose of assuring any quantity of water or specific pressure to the sprinkler system. A service charge of \$5.50 per month is provided under the contract for the service made available by Pacific Gas and Electric Company. In the event water is used Pacific Company has the right to estimate the quantity of water so used, and to charge therefor in accordance with the general rate schedule applicable in the City of Sonora.

The contract is to become effective upon completion of Pacific Gas and Electric Company's installation of the service connection, valve and service pipe and to remain in effect for a period of one year and thereafter until terminated by either party upon thirty days' written notice.

The Commission having considered the request of Applicant and being of the opinion that the application should be granted, that a public hearing is not necessary, and good cause appearing, therefore,

IT IS HEREBY ORDERED as follows:

- Pacific Gas and Electric Company be and it is hereby authorized to carry out the terms and conditions of the written contract dated June 18, 1948 with Annabel Bauman a copy of which is attached to the application as Exhibit No. 1 and made a part hereof by reference.
- 2. Pacific Gas and Electric Company shall file with this Commission within sixty (60) days two certified copies of the contract as consummated together with a statement of the date on which the contract is deemed to have become effective.
- 3. Pacific Gas and Electric Company shall notify this Commission of the date of termination of said contract within thirty (30) days thereof.
