O P I N I O N

Applicant Anthony Frank Amadeo is an individual doing business as Market Hauling Co. and is presently operating as a highway common carrier in the transportation of fresh fruits and vegetables from certain points in Santa Clara County generally to San Francisco and Oakland, pursuant to a certificate granted by the Commission in Decision No. 40532 in Application No. 27963.

Applicant Coast Line Truck Service, Inc., is a corporation operating as a highway common carrier in the transportation of fresh fruits and vegetables between specified points and places in the State of California pursuant to Decision No. 28960 in Application No. 20111; Decision No. 32456 in Application No. 22407; and Decision No. 32733 in Application No. 22856.

In this application Anthony Frank Amadeo proposes to sell and Coast Line Truck Service, Inc., proposes to buy the operative right evidenced by Decision No. 40532, and equipment, in accordance with an agreement entered into by the parties on June 28, 1948, a copy of which is attached to the application.

By the terms of said agreement the amount to be paid for the operating right, together with certain described equipment, is

\$7,500, payable as follows: \$100 upon the execution of the agreement; \$4,900 payable upon delivery by seller to buyer of a good and sufficient bill of sale of said property; \$200 per month from and after the date of sale and transfer for eleven consecutive months; and \$300 the following month.

The equipment involved in the transaction consists of six trucks, trailers and tractors, valued at \$6,000. Operative rights and good will are valued at \$1,500.

The transfer as proposed herein does not appear to be adverse to the public interest and the application will be granted. However, the action taken herein shall not be construed to be a finding of the value of the property or properties herein authorized to be transferred.

There is no necessity for a public hearing.

O R D E R

Application having been filed as above entitled, and the Commission being advised in the premises, and finding that said transfer should be authorized,

IT IS ORDERED:

(1) That Anthony Frank Amadeo is hereby authorized to sell and transfer to Coast Line Truck Service, Inc., and the latter is authorized to purchase and acquire from said Anthony Frank Amadeo, and thereafter operate thereunder, all of the right, title and interest in and to the operative right created by Decision No. 40532 in Application No. 27963, and equipment.

(2) Applicants shall comply with the provisions of General Order No. 80 and Part IV of General Order No. 93-A, by filing, in triplicate, and concurrently making effective, appropriate tariffs and time tables within 60 days from the effective date hereof and on

not less than one day's notice to the Commission and the public.

The effective date of this order shall be 20 days from the date hereof.
