#### SUPPLEMENTAL OPINION AND ORDER

Decisions Nos. 42058 to 42067, inclusive, issued September 21, 1948, incorporated in the Commission's minimum rate tariffs revised regulations for the handling of C.O.D. shipments. These tariff revisions are to become effective November 15, 1948. Through error, they provide that C.O.D. remittances are to be made to consignees instead of consignors. The necessary corrections will be made.


