OPINION

Roy E. Rankin, an individual, doing business as the Roy Rankin Water Service, owns and operates a water works in and about the unincorporated territory of Baldwin Park, Los Angeles County, and filed the above-entitled application on December 15, 1948, seeking authority to establish an increased schedule of rates.

Public hearings were held before Examiner Warner, in Los Angeles, on March 2 and April 14, 1949.

The applicant's system serves approximately 308 customers residing in and about the unincorporated territory of Baldwin Park, about two miles east of El Monte, in Tracts Nos. 10104 and 10953, and some unsubdivided parcels on the east bank of San Gabriel River lying on either side of Carvey Boulevard. The service area comprises approximately 165 acres.

Water is obtained from two pumping plants located at opposite ends of the service area; one well being 12 inches in diameter, 50 feet deep, and discharging 567 gallons per minute at 50 pounds pressure p.s.i.; the second well being 18 inches in

diameter, 194 feet deep, with approximately the same discharge. Two hydropneumatic tanks are especially constructed and installed at each pumping plant to prevent sand from passing into the distribution system. The distribution system consists of 27,924 feet of steel water mains, ranging from 1% to six inches in diameter.

The present rates were established by the Commission in its Decision No. 29231 issued November 2, 1936. There are no flat rates effective in this system. Meter rates provide for a minimum charge of \$1.50 per meter per month, including 2,000 cubic feet or less; and 40 cents per 1,000 cubic feet for the next 8,000 cubic feet; and 25 cents per 1,000 cubic feet for all over 10,000 cubic feet.

The proposed rates provide for a minimum charge of \$1.50 per month, including the first 1,000 cubic feet; 60 cents per 1,000 cubic feet for the next 9,000 cubic feet; and 50 cents per 1,000 cubic feet for all over 10,000 cubic feet.

Mr. Carr A. Dietz, accountant for applicant, testified regarding applicant's financial operations for the year 1948. The revenues and operating expenses totaled 38,199 and \$8,577, respectively, and resulted in an operating loss of \$478 for the year's operation. The operating expenses included \$1,266 as an allowance for depreciation which was computed by the straight line method. The applicant reported the fixed capital to be \$13,887, as of December 30, 1948.

Mr. W. F. Wilson, one of the Commission's engineers, presented a report covering an appraisal of the system on an historical cost basis, and the results of operation for the year 1948, under present rates, and estimated for the year 1949, under the proposed rates. A summary of the results of operation shown in the report for the two years follows:

Mr. Wilson testified that using a 5% depreciation annuity of \$659 for the year, the rate of return with the undepreciated rate base would be 0.26% per annum for the year 1948 and 3.68% for the estimated year 1949 at the proposed rates.

Several witnesses protested an increase in rates on the grounds that the present charges were excessive. These witnesses also complained of low pressures during periods of peak demand and also that sand and other foreign materials appeared in sinks and bathtubs from time to time.

The record shows that the customers of this system have enjoyed very low rates and that the proposed rate will still leave

it among the lowest in the general vicinity. In connection with the service complaints, applicant should take immediate steps to furnish potable water at adequate pressures.

However, it is concluded that the rates requested by the applicant would not yield an excessive return, and that the applicant is entitled to certain relief, and the order herein will, therefore, provide for rates which will increase revenue by approximately \$1,850 annually.

ORDER

Roy E. Rankin, an individual, doing business as the Roy Rankin Water Service, having applied to the Commission for an order authorizing increase in water rates and charges, a public hearing having been held, and the matter having been submitted for decision.

IT IS HEREBY FOUND AS A FACT that the increase in rates authorized herein is justified; therefore,

IT IS MEREBY ORDERED that applicant is authorized to file in quadruplicate with this Commission after the effective date of this order, in conformity with this Commission's General Order No. 96, the schedule of rates shown in Exhibit A attached hereto, and, after not less than five (5) days' notice to the Commission and to the
